President Hunter called the regular meeting of the Board of Commissioners to order at 7:00 p.m.

President Hunter led those present in the Pledge of Allegiance.

District Counsel reported there was no Closed Session.

PUBLIC COMMENT

David Elsebusch reported there is a vacancy on the Headwaters Fund Board and said he would like to see someone appointed who is "friendly" to the Harbor District. February 13th is the last day to apply for the position. Mr. Elsebusch said he is going to file a complaint with the IRS Whistleblower office regarding the payment of District officers through their business. He also said he took exception to the way the claim from Christopher Fonda was handled; and he said the Board of Commissioners is famous for inappropriately chatting about issues in Closed Session.

Commissioner Higgins said the issue was discussed in Closed Session, but then discussed in the open meeting.

President Hunter said the Board never takes action or discusses issues in Closed Session that are not immediately disclosed in the open meeting.

Marcus Brown said the Timber Heritage Association members are trying to find sources of revenue to continue on with their project. He said they have an older Business Plan, but it needs revision; and they would like to meet to discuss their next step.

CEO stated the Harbor District's EIR would be for the whole project; THA will need to develop their specific project description to put into the document.

Commissioner Wilson cautioned staff to be mindful that the Harbor District does not become the planning staff for THA.

Commissioner Pellegrini suggested THA hire a planner to develop their project needs.

Penny Elsebush asked what is the basis for determining whether an issue is anticipated litigation for Closed Session requirements. She said the discussion about Christopher Fonda's claim should have been done in an open meeting.

District Counsel stated it was clear there was threatened litigation in the wording of Mr. Fonda's claim.

Commissioner Pellegrini

- Reported she and Commissioner Wilson attended the Humboldt Bay Management Plan Advisory Committee meeting on January 14th. She complimented Director of Conservation and District Planner for a good meeting and said the committee is working on presently prioritizing the Plan policies.
- Said a friend had given her maps of Humboldt Bay dating back to 1851, which she will give to Director of Conservation.
- Reported the Headwaters Fund Board has given their recommendation to the Board of Supervisors for their approval of a \$500,000 grant for the City of Eureka to build an ice facility. She said the City staff did an excellent job of presenting this project for grant funding.
- Said she is working with Eureka High School administration to develop a maritime pathway curriculum for the students. Classes might be shipbuilding, fishing industry, etc.
 Stephen Pepper said he came across an article in a trade magazine about such a curriculum. He offered his company, Humboldt Maritime Logistics, to help in any way in order to give back to the community.

Commissioner Wilson:

- Reported Congressman Thompson is promoting the re-establishment of the offshore oil drilling ban. Commissioner Pellegrini suggested a report from one of his staff members at a future meeting.
- Reported he attended the Humboldt Bay Management Plan Advisory Committee meeting.
- Said he missed the EBM workshop and asked that announcements of upcoming public meetings be sent to the Board of Commissioners.
- Said the expansion of a maritime academy system would be beneficial. Commissioner Curless said he spoke with College of the Redwoods representatives about ten years ago and they were interested in a putting together a boat-building course. Commissioner Pellegrini suggested Ron Fritzsche be contacted for courses at Humboldt State University. Director of Maritime Commerce reported he spoke with HSU President Rollin Richmond to put transportation courses in the HSU curriculum.

Commissioner Hunter:

Reported he will attend the Annual Eureka Chamber of Commerce dinner on January 29th. Commissioner Hunter, as outgoing Chamber Board President will pass the honor to Chris Crawford as the incoming President.

NEW BUSINESS

A. CONSIDERATION OF COMMENTS ON US MARITIME ADMINISTRATION'S INTERIM FINAL RULE ON AMERICA'S MARINE HIGHWAY PROGRAM.

CEO said the comments are on the development of the structure of the Marine Highway Program. Stephen Pepper, Humboldt Maritime Logistics, has also sent in a comment letter in order to show substantive interest for this program.

The Board of Commissioners discussed the letter and suggested several changes.

David Elsebusch said the letter was supportive of the whole West Coast, not just the Port of Humboldt Bay. He asked if the Marine Highway Program will really reduce landside congestion.

Commissioner Wilson said while the Port of Humboldt Bay may not be the major port for some things, it would be the hub for the maintenance and operations of their business.

Commissioner Pellegrini stated congestion is one of the largest threats to prosperity. In the next 15 years, cargo will double and since the majority moves on land, this is significant.
