Item B: Commissioner Higgins asked CEO if it was necessary to send two (2) employees to the Work Boat Show. CEO responded the two Bar Pilots are part of the committee researching the purchase of this type of vessel. Others on the committee are from local emergency response agencies. The purchase of the vessel is covered by grant funding. If the research (travel) expenses are not covered by the grant, the employees will not travel.

CEO stated the State performed a vulnerability assessment for Humboldt Bay approximately 1 ½ years ago and determined there was no good database where safety and security landmarks can be identified. The system will identify all properties around Humboldt Bay where the Harbor District has legal access. Private landowners will benefit from heightened security for their property. The Harbor District is the conduit because of the grant source, but the system will be used by the Sheriff's Department, Coast Guard, local fire departments etc.

District Counsel stated the last union contract expired June 30, 2009. The item on this agenda is the latest proposal from the employee union.

Suzie Howser, representing the employee union, said the proposal agrees the salaries of classified employees are frozen until June 30, 2009. Also, the items from Ordinance No. 1 that are not included in the Personnel Policy are to be binding.

Commissioner Higgins said he appreciates the work of the employee union, but said there seems to be some confusion over the "sunsetting" of Ordinance No. 1. He said he does not believe there was anything taken away from the employees. Ms. Howser said there are still some issues that need to be clarified with the Human Resources Committee.

District Counsel stated the Human Resources Committee has a counter-proposal to present to the employee union he said he was optimistic would answer the employee union's concerns.
