NEW BUSINESS

President Curless moved Item 11(a) to this place in the agenda.

A. CONSIDERATION OF APPOINTING TWO DISTRICT COMMISSIONERS TO MEET WITH THE HUMBOLDT BAY MUNICIPAL WATER DISTRICT REGARDING COMMERCIAL WATER USE.

Carol Rische, General Manager of the Humboldt Bay Municipal Water District (HBMWD), and Kaitlin Sopoci-Belknap, Board Member of HBMWD, explained with the recent loss of the pulp mill HBMWD's revenue has been affected. An Advisory Committee was formed to research options and receive public input. As a result of the Advisory Committee's work, the top three water use options recommended to the HBMWD Board are 1) local commercial/industrial water sales, which would include water for aquaculture; 2) transport of water to another public agency outside HBMWD and 3) consideration of dedicating some portion of the available water for in-stream flows if there is demonstrated environmental benefit of such.

Initial meetings are being scheduled with interested parties such as the Harbor District to discuss commercial water use options. Commissioners Pellegrini and Marks agreed to meet with Ms. Sopoci-Belknap and Bruce Rupp.

CEO REPORT

- Shelter Cove Breakwater Rehabilitation Project was started on November 19 and completed on December 4. Some road and ramp repair will have to wait for better weather. It took 11 years to fund and permit the project and a little over 2 weeks to construct the new breakwater. CEO has already received an email from a happy Shelter Cove resident.
- The Sea Level Rise Partnership Council met on November 18 for the first time There was good participation from staffs of Harbor District, City of Arcata, City of Eureka and the Wiyot tribe.
- On November 19 the District received its new grant-funded port security truck. It is a great addition for the District and necessary for hauling response equipment, etc.
- Director of Maritime Commerce continues to work with local cargo handling equipment operators on exemptions to the Mobile Cargo Handling Equipment Regulation.
- Misty Schmidt's last day as Clerk for the Harbor District was November 30. Kim Farrell is the temporary Clerk.
- CEO met with PG&E representatives on December 8 on dredging the King Salmon Canal. PG&E has now dedicated internal resources to this issue and continues to make progress.
- On December 9, CEO and Mark Andre from the City of Arcata met with George Williamson of LAFCO regarding the process that would need to be followed if the District is to acquire the assets and functions of Reclamation District 768 in Arcata Bay. CEO will continue to review the information and will likely return to the Board of Commissioners with a proposal in the future.
- The District's Employee Recognition Dinner was held on December 11. CEO thanked Commissioners Marks and Higgins for attending the event.

Commissioner Wilson asked if Berths 1 and 2 were being used currently. CEO stated staff has tried to pursue interim uses, but the berths are too shallow. At least two different businesses have been turned away due to the shallow draft situation. This hydrographic survey is necessary for the environmental documents, which are still at least one year away from completion. CEO reported he is meeting with the Regional Water Quality Control Board next week regarding the upland disposal site repermitting.
