Mr. Berman reported the District will be the administrator and the final application would come before the Board for approval.

CEO stated Wild Planet has decided to delay a decision on this lease; but there are other companies existing that may need the space. Mr. Crider reported there are out-of-town processors interested in expanding into this area and although he knows local processors will not be happy about the competition, the District is a public agency with public docks. CEO said once the Redwood Marine Terminal Building 14 is demolished, it opens up the south side of the dock, which is the best side.

Ted Kuiper arrived late and President Wilson allowed him to make public comment due to the change of the regular meeting time. Mr. Kuiper reported he spent some time looking at potential rental rates for the Freshwater Tissue Company property if the District is successful in the purchase. He has received information from Port Hueneme and several aquaculture innovation centers. Mr. Kuiper said there are at least four companies that would like more acreage for their aquaculture operations; other areas are interested in the results of the District's pre-permitting process.

Mr. Bates asked that those interested re-read the letter in a different light; he reported the Proposed Woodley Island RV Park has gotten the attention of the fishing fleet.

Susan Penn stated she has concerns with the new RV Park report recently received.

Commissioner Wilson said Mr. Bates and Ms. Penn are on the RV Park Subcommittee and asked that they make their concerns known there as well.

Commissioner Higgins reported the RV Park Subcommittee will meet next week.

Carol Krueger stated the District should initiate dialogue with other agencies to get their feedback; she said George Williamson of PlanWest Partners has not done that.

Randy Lowell, new State Aquaculture Coordinator for the California Department of Fish and Wildlife, introduced himself to the Board and said his involvement with aquaculture started 30 years ago. Mr. Lowell reported there are many exciting things happening in Humboldt Bay regarding aquaculture; he offered his assistance.

Commissioner Higgins stated he is glad the position has been filled; he said he knows a few other people that will be happy to hear the news.

- Gave tours of Freshwater Tissue Company property to Humboldt State University and aquaculture representatives.

- Has been working with the Coastal Conservancy to submit a grant application to CalTrans to assist with Spartina eradication.
- Reported the highest King Tides in 2012 were in December; stated Humboldt Baykeeper organized photo committees for the event.
- Said the Building 14 demolition is complete.
- Has been working on a Permit for levee repair near Liscom Slough; reported it will go out for public comment soon.
- Stated Pacific Gas and Electric has put out a report regarding the potential dredging of King Salmon Canal; they are accepting comments through the end of January. Mr. Berman said the King Salmon community has been very excited, even though the residents would have to contribute financially to the dredging of the finger channels.
- Reported the District has exchanged a series of letters with CalTrans asking them to review information regarding the billboards on District tidelands; said CalTrans responded to the first two letters asking the District to deal directly with the offending company. CalTrans is no longer responding to the District's requests.

Commissioner Wilson asked staff to set up a meeting with CalTrans representatives.

Ken Bates reported in the past two years, there were two storms with tides higher than the King Tides that came in January.

CEO reported Ted Kuiper and Erika Blackwell have been working very hard on the aquaculture innovation project; these funds will help secure additional staff to help with the project.

Erika Blackwell said she is very excited about the project and thinks the District is the best agency to accept the funds; stated she is thrilled about the pulp mill site.

Commissioner Wilson reported the timing is good on this project and that it does not only involve pilot projects, but includes a tenancy aspect. He said the consultants hired for the project have experience refurbishing a pulp mill.

Sid Berg of the Humboldt Building Trades Council stated he has questions about how the money is being applied and if jobs are being created.

CEO reported three consultants will be helping with the re-purposing of the pulp mill; it also helps Taylor Shellfish expand their operation. Mr. Crider asked Mitch White, Operations Manager of Taylor Mariculture LLC, to talk about the possibility of job creation.

Mitch White said this facility will open up the opportunity to expand operations; while the Berth 2 Taylor Mariculture operation has been designed to fit into the space they now occupy, the initial Permit included eight to ten jobs. Mr. White stated there are no exact numbers yet on how many jobs will be created if they are able to use warehousing.

Todd Van Herpe of Humboldt Bay Oyster reported he is happy about the expansion.

Ted Kuiper said after speaking with many people and consultants involved in the processes the District is interested in creating at Freshwater Tissue, the project has the possibility of creating many jobs.

Sid Berg asked if the facility would be compatible with future shipping requirements.

Commissioner Higgins stated it is a large facility and a dock could be efficient.

Letter Expressing Interest in the "Alternative Rail Route Feasibility Study" proposal.

To: Lance Madsen, UpState RailConnect Committee

Cc: City Manager, City of Eureka CEO, County of Humboldt

This letter is to express our interest in the results of a study of alternative railroad routes to Humboldt Bay advocated by the UpState RailConnect Committee. The Harbor District has, since its inception, consistently been a supporter of operation, reestablishment and preservation of a rail line connection to the Port of Humboldt Bay. We recognize that type of infrastructure as potentially important to our local and

While we support the general concept your group is promoting to the district, we would like to take this opportunity to make some recommendations and requests that we believe will further your efforts.

regional economy. We applaud your intentions and efforts towards this end.

The Harbor District recommends that before expending significant resources on comprehensive environmental, geotechnical, jurisdictional, and engineering analysis that a capital, market and operational cost models be used to conduct a fundamental economic and financial review of the proposed concept. This would help our district, and regional planning agencies to be strategic and effective in how we prioritize our financial, staff and political resources to achieve the desired connectivity. If this initial review of the data should suggest likely success then more detailed studies mentioned above could be warranted.

Historically and currently the Harbor District's policies have been focused on the restoration and preservation of rail service along the State-owned 300 mile long North Western Pacific Railroad from the Port of Humboldt Bay south to its connection with the national rail system near northern San Francisco Bay. There has been significant public investment and many years of effort towards this end. Efforts related to establishing alternative rail routes to Humboldt Bay could significantly impact these efforts. In addition, the existing NCRA line is the reference point by which this community and the Harbor District would evaluate any alternative route either economically and/or environmentally. We believe that a balanced understanding of the issues and consistency with established policies requires that the alternatives study include a direct comparative analysis with restoration of the existing NCRA line.

As an agency with direct jurisdictional interest in Humboldt Bay transportation, we request that any information gathered in this effort to return rail be shared with the Harbor District, so that we can account for that information and avoid duplication in our planning and management efforts to efficiently manage and promote bay related commerce. Due to the competitive nature of project funding and so that our interests

and concerns are not mistakenly misrepresented, the Harbor District requests that you involve us in your future funding requests. Therefore we request that support letters for grants and other funding sources be requested from the Harbor District on a case by case basis.

We look forward to hearing about your progress and being included in future communications.
