# MINUTES REGULAR MEETING OF THE BOARD OF COMMISSIONERS HUMBOLDT BAY HARBOR, RECREATION AND CONSERVATION DISTRICT

March 26, 2009

#### PRESENT:

#### ABSENT:

Commissioner Pellegrini

President Hunter called the regular meeting of the Board of Commissioners to order at 7:00 p.m.

President Hunter stated Commissioner Pellegrini was absent due to several recent family tragedies and asked everyone to keep her in their thoughts.

President Hunter led those present in the Pledge of Allegiance.

District Counsel reported on the items discussed during Closed Session: Status of negotiations with the Harbor District employee union and the Real Property Negotiations potential purchase of Mario's Marina property in Shelter Cove. No action was taken on these items during Closed Session. Also during Closed Session, Commissioner Hunter recused himself and the rest of the Board discussed the South Bay Marina lease renewal. No action was taken on this item; consideration will take place later in the agenda for the open meeting.

#### **PUBLIC COMMENT**

David Elsebusch said the Planning Commission is considering revisiting the County Redevelopment proposal, which would have an effect on the Harbor District as well as others.

Lawrence LaBranche thanked the Board of Commissioners for working with the Timber Heritage Association. He said this summer they hope to get the speeder working between Manila and Samoa.

#### CONSENT CALENDAR

COMMISSIONER WILSON MOVED FOR THE APPROVAL OF THE CONSENT CALENDAR. COMMISSIONER CURLESS SECONDED. MOTION CARRIED WITHOUT DISSENT.

#### **CEO REPORT**

- 3/18-19: Attended CAPA meeting. Met with the new secretary of State's new Emergency Management agency (OHS and OES). State security grants are being held up (along with essentially all other bond-related grants from the State) until after the May 19th election. Even if the tax increase passes, the State may still be \$7-8 Billion in the hole. Also discussed new legislation that has been introduced this year (State). Also learned that all CA ports are in same boat as Humboldt is, i.e., cargo down, freezing positions, cutting where they can, continuing to rebuild infrastructure.
- 3/23-26: Chaired CMANC's 50<sup>th</sup> anniversary Washington Week visit. Conducted 14 meetings over 2 solid days. Met with new OMB director and staff; Corps of Engineers, RAMP coalition, MARAD, House and Senate Energy and Water appropriators, Assistant administrator for NOAA NOS, House Chair of the NR Subcommittee on fisheries, wildlife and oceans as well as with Senators Boxer and Feinstein's staff. Will Edington and CEO met with Boxer, Feinstein and Thompson's staff and worked on Harbor Maintenance Tax and our MARAD issues. Issues covered included the FY09 funding; FY10 appropriations; Stimulus (now America's Recovery and Reinvestment Act); marine sanctuaries, Marine highway, maritime education

program, shipyard grant program and our legislative priorities. Since CEO was Chair, we engaged Congressman Mike Thompson to do the welcoming at the 50<sup>th</sup> CMANC Golden State Reception. Good meetings overall. CEO thanked office staff for the great job they did to help CEO get the materials for the event organized and shipped.

- 3/16-19: Director of Maritime Commerce participated in the annual SeaTrade convention regarding cruise ships. This year he made good progress toward assembling the team of the other ports for the Cruise Californias itinerary. Met with various lines throughout the week and got good feedback.
- Director of Facility Maintenance, Director of Conservation Division and the Pilots are continuing to work with HSU to install a ADCP that will not only track currents, but also will record any tsunami currents.
- 3/22: Dredge Yaquina arrived to begin its 30 days of channel maintenance.

- Attended the Salmonid Restoration Federation Conference. The State's budget was discussed and there is a perception the State is incapable of fulfilling its financial obligations.

- Said the Economic Development Committee is getting close to being a reality. He said there will be 6-10 focus meetings.

#### **NEW BUSINESS**

A. CONSIDERATION OF RECEIVING AND FILING PERMIT APPLICATION NO. 09-03 TO HUMBOLDT STATE UNIVERSITY FOR THE HUMBOLDT BAY AQUATIC CENTER FLOATING DOCK PROJECT.

CEO reported the Humboldt Bay Aquatic Center was built initially with no dock. Due to the narrowness of the channel, Dave Nakamura of HSU and the City of Eureka met with the Harbor Safety Committee to get feedback to develop a plan for the floating dock which would be agreeable to all parties involved.

B. CONSIDERATION FOR SUBAWARD GRANT AGREEMENT WITH THE SOUTHERN CALIFORNIA COASTAL WATER RESEARCH PROJECT FOR PROGRAMMATIC AND TECHNICAL ACTIVITIES RELATED TO THE DEVELOPMENT OF A STATEWIDE NETWORK OF REFERENCE WETLANDS IN CALIFORNIA.

CEO reported this is an amendment to the current SCCWRP agreement.

COMMISSIONER HIGGINS MOVED FOR THE APPROVAL OF THE SUBAWARD GRANT AGREEMENT WITH THE SOUTHERN CALIFORNIA COASTAL WATER RESEARCH PROJECT FOR PROGRAMMATIC AND TECHNICAL ACTIVITIES RELATED TO THE DEVELOPMENT OF A STATEWIDE NETWORK OF REFERENCE WETLANDS IN CALIFORNIA. COMMISSIONER CURLESS SECONDED.

# C. CONSIDERATION OF 2009 EXTENSION OF TIDE AND SUBMERGED LANDS LEASE WITH THE ESTATE OF G.A. HUNTER FOR SOUTH BAY MARINA.

Commissioner Hunter recused himself and left the room during the discussion. He did not participate in either the discussion or the vote.

COMMISSIONER WILSON MOVED FOR THE APPROVAL OF THE 2009 EXTENSION OF TIDE AND SUBMERGED LANDS LEASE WITH THE ESTATE OF G.A. HUNTER FOR SOUTH BAY MARINA. COMMISSIONER HIGGINS SECONDED. MOTION CARRIED WITHOUT DISSENT.

#### D. FY 2009/10 BUDGET WORKSHOP.

CEO gave a PowerPoint presentation to the Board of Commissioners highlighting potential revenue enhancements and expense reductions. A 12.5% increase to Woodley Island slip fees and storage fees for Harbor District properties was included.

Commissioner Wilson said even if the pulp mill does start up, there is no guarantee of any shipping, which would bring in more revenue to the District. CEO responded the option recommended by staff does not count on the pulp mill returning to production. He said talks with the pulp mill owners about short sea shipping opportunities continue.

Commissioner Wilson asked if pilots were required on smaller barges – those that would be involved in the short sea shipping. CEO stated bar pilots can be required by the Board of Commissioners and a revision to the tariff ordinance would be required.

Commissioner Wilson said the revenue received from Captain Petrusha training pilots would not cover the current pilot salary and would therefore not be a money-maker. CEO stated it would be a cost deferment.

Commissioner Wilson asked what would happen if the District's cash reserves fell below the \$1 million required by the bonding company. CEO stated that is something we are trying to avoid.

Commissioner Wilson said the budget is being portrayed as an "either or" situation – harbor development or none. He said there will be some serious discussion in the next couple of months. It is a bullish position that ports are going to grow on the West Coast. He said the District does not have the five years it will take to realize such growth and he would like to reevaluate this situation before everything collapses.

CEO said if the Board of Commissioners desires to take this as incentive and push hard towards port development staff will put together some milestones so the progress can be tracked. On the other hand if the Board of Commissioners decides to be done with harbor development then that is a different path.

Commissioner Higgins said he differs with CEO on trade projections – The New York Times states sales, shipping, etc is dropping – it is an economic tsunami. He said the Board of Commissioners should look to

restructure/reorganize. He suggested there be a discussion of options with the pilots. The District will not have vitality if reserves get down to \$1 million. It is time to be resourceful.

Commissioner Curless recounted the story of when the property was sold to the Weather Service. By the time the debts were paid and the State took its piece, there was not much money left over. It would be the same if the boat yard or the marina were sold.

Commissioner Higgins said he does not believe the Board of Commissioners will end shipping in Humboldt Bay with moves that are made to put the District in a clearly sound position.

Jay Wright (ret. Coast Guard) said assumptions on West Coast trade rebounding are rosy. Cargo capacity would be absorbed by other Southern California ports before it comes here. There is no infrastructure in place to realize short-term rebound.

Dave Spreen: Other ports are already geared up – would like to see new economic development direction. Use the Redwod Marine Terminal property for green port technology/industrial park.

David Elsebusch suggested the Board "rent-a-pilot". He asked if it was impossible to acquire pilots on a temporary basis.

Susan Penn said the Board should hurry with the Economic Development committee. She asked if the fishing community is considered when the US Army Corps of Engineers is looking at safety issues to determine the priority of dredging Humboldt Bay's bar and entrance. CEO replied tonnage is the determining factor, not safety.

Ms. Penn commented on the TranSystems report inferring the success of the Redwood Marine Terminal is contingent on the railroad. Commissioner Curless stated the Humboldt Redwood Lumber Company at Scotia hopes the railroad between South Fork and Eureka opens soon because they have plans to move lumber from Scotia to Eureka to ship out of Humboldt Bay.

Penny Elsebusch also stated the Economic Development Committee needs to be organized soon. She said if the Harbor District cannot sell properties, then leasing should be considered. Commissioner Hunter said staff has tried to find lessees in the past for the Boat Yard, but to no avail.

Dave Spreen asked if more grant writers could help bring in revenue. CEO replied grants are short-term by nature and would require more employees to do the work of the grant.

Penny Hickey asked the Commissioners if they have any suggestions for options for the pilot situation. Commissioner Higgins said he wants to maintain Humboldt Bay's capacity for shipping and there needs to be dedicated discussion with creative solutions. Commissioner Wilson said he was not prepared to provide options since this Board meeting was for the staff to give options.

Rich Trygar saluted the Board and their thoughts concerning revenue enhancement and minimizing costs. He said there will be several meetings to discuss all options. No lives have been lost since the deepening of the bar and entrance; prior to that an average of one death per season. Mr. Trygar fears that if the Board opts to take actions that would minimize or eliminate shipping that dredging could stop and lives will again be lost. Mr. Trygar said this is still spring training; it is too early in the game to forfeit.

The next budget workshop will be held on April 9<sup>th</sup>.
