#### **11. Unfinished Business**

#### a) Consider Approval of Amendment No. 1 to the Tuluwat Island Wetland Mitigation Project Agreement with CalTrans

*Recommendation:* 1) Approve terms related to Amendment No. 1 of the Tuluwat Island Wetland Mitigation Project (Project) Cooperative Agreement; 2) Authorize the District Attorney to make nonmaterial amendments to the Agreement as may be required by CalTrans; 3) Authorize the Executive Director to execute the amendment and contracts based on these terms; and 4) Bring the final agreement back to the Board for public disclosure.

*Summary:* On March 4, 2021 the Harbor District entered a cooperative agreement with Caltrans related to implementation of the Tuluwat Island Wetland Mitigation Project. On September 9, 2021 the Board conditionally approved a contract with the Redwood Community Action Agency (RCAA) to implement the project with the Wiyot Tribe to provide cultural monitoring pending approval of the attached funding agreement.

#### b) Informational Update on Easements Through the Town of Samoa Properties

*Recommendation:* Staff is presenting this as an information item to notify the Board of its completion of those actions approved in the September 09, 2021 Board Meeting related to certain easements serving the Town of Samoa and Harbor District property.

*Summary:* Whereas certain easements existed between the Town of Samoa, LLC (Samoa) and the District, centered around what is known as Vance Avenue, current and future development necessitated the need for updated easements.

#### 12. New Business

a) Letter of Support for Senate Bill (SB 307) McGuire, A Bill Prohibiting Spending State Moneys for Any New Bulk Coal Terminal Project within the County of Humboldt *Recommendation:* Staff Recommends that the Board submit a letter of support for SB 307 and direct staff to continue to work with Senator McGuire, Humboldt County, City of Eureka and other partners to rail bank the former North Coast Rail lines North of Willits.

*Summary:* As reported in the January 5th Times Standard, SB 307, introduced by state Sen. Mike McGuire (D-Healdsburg), would block a proposal to restore the defunct North Coast railroad in an attempt to export coal overseas from Montana, Utah and Wyoming through the Port of Humboldt Bay by prohibiting the use of state funds for any new bulk coal terminal project within Humboldt County.

#### b) Status Report on the Nordic Aquafarms Environmental Impact Report and Regulatory Agency Permitting Timelines for the Proposed Recirculating Aquaculture Facility at Redwood Marine Terminal II

*Recommendation:* Staff Recommends that the Board: Receive an informational report from Staff and take no action on this item.

Summary: THIS IS NOT A HEARING. The Harbor District has a lease agreement with Nordic Aquafarms to develop an indoor recirculating aquaculture facility at Redwood Marine Terminal II. After consultation with the County of Humboldt, Coastal Commission, State Water Board, and Harbor District Staff it was determined that a consolidated Environmental Impact Report (EIR) would be prepared for the entire project and that the County of Humboldt would be the lead agency under CEQA. The County has Noticed the Availability of the EIR and is accepting Public Comments until February 18, 2022. <u>The County of Humboldt is the lead agency and</u> **all comments on the EIR should be directed to the County and NOT to the Harbor District.**

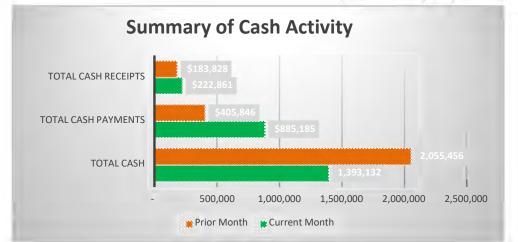

## STAFF REPORT HARBOR DISTRICT MEETING January 13, 2022

TITLE: Amend Clean Earth Contract to Remove Hazardous Materials from Redwood Marine Terminal II by Increasing Contract by \$9,100

**STAFF RECOMMENDATION:** Staff recommends the Board: Approve an increase in the contract with Clean Earth in an amount not to exceed \$9,100 to remove approximately 605 gallons of regulated waste from Redwood Marine Terminal II.

**SUMMARY:** In June of 2021, the Board approved a contract with Clean Earth in the amount of \$18,064.20 to dispose through a Treatment, Storage and Disposal Facility, approximately 810 gallons and 7,250 pounds of regulated waste which the District acquired through the purchase of the Samoa pulp mill. All the material except 605 gallons has been removed from the site. The contract amendment is required to remove the remaining hazardous material.

**DISCUSSION**: Due to the method of disposal of these materials by incineration, and those regional hazardous waste incinerators experiencing reduced capacity due to labor shortages and other affects, the intended disposal site has been unable to accept the material. After several such attempts, Clean Earth worked to find an alternate site to accept the materials, however at an increased cost including that for overpack drums. Pending approval of Quote Addendum (attached) Clean Earth is prepared to schedule the material for incineration.

**STAFF RECOMMENDATION:** Affirm the findings made in Resolution 2021-16 regarding the continued state of emergency and authorize the continued use of virtual meetings.

**SUMMARY:** On October 14, 2021 the Board of Commissioners adopted Resolution 2021-16 and, as per Section 4 of that Resolution, agreed to reconsider the findings within 30-days. The findings remain in effect as the COVID-19 pandemic has not subsided and the Governor issued Executive Order Nos. N-08-21, N-25-20 and N-29-20, which suspended certain provisions of the Ralph M. Brown Act to allow legislative bodies to conduct public meetings without strict compliance with the teleconferencing provisions of the Brown Act remains in place. Assembly Bill 361, which was signed into law in September of 2021, amended Government Code section 54953, to provide relief from the teleconferencing provisions of the Brown Act under certain circumstances provided the legislative body makes certain findings.

**DISCUSSION:** As a result of the COVID-19 pandemic, the Humboldt County Health Officer has imposed and has recommended measures to promote social distancing as more particularly set forth in his August 6, 2021, Order, among other prior orders and guidance. ## STAFF REPORT HARBOR DISTRICT MEETING January 13, 2022

**TITLE:** Consider Approval of Amendment No. 1 to the Tuluwat Island Wetland Mitigation Project Agreement with CalTrans

**STAFF RECOMMENDATION:** 1) Approve terms related to Amendment No. 1 of the Tuluwat Island Wetland Mitigation Project (Project) Cooperative Agreement; 2) Authorize the District Attorney to make nonmaterial amendments to the Agreement as may be required by CalTrans; 3) Authorize the Executive Director to execute the amendment and contracts based on these terms; and 4) Bring the final agreement back to the Board for public disclosure.

**SUMMARY:** On March 4, 2021 the Harbor District entered a cooperative agreement with Caltrans related to implementation of the Tuluwat Island Wetland Mitigation Project. On September 9, 2021 the Board conditionally approved a contract with the Redwood Community Action Agency (RCAA) to implement the project with the Wiyot Tribe to provide cultural monitoring pending approval of the attached funding agreement.

## **DISCUSSION** Terms for Amendment to the Tuluwat Island Wetland Mitigation Project Cooperative Agreement

- District costs to be reimbursed by Caltrans shall not exceed 13% of total Project costs \$774,724.
- Harbor District will contract with the Wiyot Tribe to provide a Tribal Monitor for the Project for a cost not to exceed \$230,572.
- Harbor District will contract with RCAA to implement the Project for a cost not to exceed \$5,728,843.
- The District's Legal Counsel will include specific language requiring Caltrans to indemnify and defend the District for Caltrans' determination that this project is exempt from both State and Federal prevailing wage laws.

#### TULUWAT ISLAND WETLAND MITIGATION PROJECT

#### AMENDMENT NO. 1 TO COOPERATIVE AGREEMENT 01-0394

THIS AGREEMENT, ENTERED INTO EFFECTIVE ON \_\_\_\_\_\_, 2021, is between the STATE OF CALIFORNIA, acting by and through its Department of Transportation, referred to herein as "CALTRANS," and the Humboldt Bay Harbor, Recreation and Conservation District, referred to herein as "HBHRCD."

#### RECITALS

- 1. CALTRANS and HBHRCD, hereinafter referred to as "PARTIES," pursuant to Streets and Highways Code sections 114 and 130, are authorized to enter into this Agreement.
- 2. CALTRANS intends to construct improvements to U.S. Route 101 in Humboldt County, within the Safety Corridor, between the Cities of Eureka and Arcata from PM 79.9 to PM 86.3, consisting of several safety construction projects as follows: Tide Gate Replacement (01-0C930); Jacoby Creek Bridge Replacement (01-0E000); Extension of Acceleration/Deceleration Lanes and Lighting Improvements (01-0F220); Guardrail and Cable Rail Safety Barrier (01-0C970); and Indianola Interchange and Airport Road Improvements (01-36600), collectively referred to as ROADWAY PROJECTS. The ROADWAY PROJECTS will collectively result in permanent impacts to 10.25 acres of coastal wetlands.
- 3. Pursuant to the California Coastal Act (CCA), the California Coastal Commission issued a Coastal Development Permit (CDP) identified as CDP #1-18-1078, dated September 13, 2019, for the ROADWAY PROJECTS. As set forth in Condition 5 of the CDP #1-18-1078, a project has been developed to eradicate invasive plant *Spartina densiflora* (Spartina) within the Humboldt Bay in order to mitigate for the ROADWAY PROJECTS' impacts to the 10.25 acres of coastal wetlands. A copy of CDP #1-18-1078 is attached to Cooperative Agreement 01-0394 as **Exhibit A**.
- 4. The City of Arcata, in cooperation with CALTRANS as the National Environmental Policy Act (NEPA) Lead Agency, has constructed the Arcata Bay Trail North Project, also known as the Humboldt Bay Trail North Project, hereinafter ABTN PROJECT. The ABTN PROJECT has resulted in impacts to 2.26 acres of coastal wetlands. As set forth in the NEPA revalidation for the ABTN PROJECT, dated July 15, 2020, CALTRANS will undertake the mitigation for the ABTN PROJECT's coastal wetland impacts. A copy of the NEPA Revalidation is attached to Cooperative Agreement 01-0394 as **Exhibit B**.

- 5. Pursuant to the CCA, a material amendment to the ABTN PROJECT's CDP #1-16-0122, has been, or will be, submitted to the California Coastal Commission in order to document that a mitigation project that will be implemented to eradicate the invasive plant Spartina within Humboldt Bay and thereby mitigate for the ABTN PROJECT's impacts to 2.26 acres of coastal wetlands. A copy of the material amendment and CDP will be provided to HBHRCD after the material amendment is issued and acknowledged by the City of Arcata.
- 6. The County of Humboldt, in cooperation with CALTRANS as the NEPA Lead Agency, intends to construct the Humboldt Bay Trail South Project, hereinafter HBTS PROJECT. The HBTS PROJECT will result in impacts to 6.10 acres of coastal wetlands. As set forth in the NEPA revalidation for the HBTS PROJECT, dated July 16, 2020, CALTRANS will undertake the mitigation for the HBTS PROJECT's coastal wetland impacts. A copy of the NEPA Revalidation is attached to Cooperative Agreement 01-0394 as Exhibit C.
- 7. Pursuant to the CCA, an application for a CDP for the HBTS PROJECT has been, or will be, submitted to document that a mitigation project that will be implemented to eradicate the invasive plant Spartina within Humboldt Bay and thereby mitigate for the HBTS PROJECT's impacts to 6.10 acres of coastal wetlands. A copy of the CDP will be provided to HBHRCD after it has been issued and accepted by the County of Humboldt.
- 8. The ROADWAY PROJECTS, ABTN PROJECT and HBTS PROJECT, which are collectively referred to as PROJECTS, will impact a total of 18.61 acres of coastal wetlands. Therefore, to mitigate for PROJECTS' impacts to 18.61 acres of coastal wetlands impacts, a mitigation project was developed to eradicate approximately 178 acres of Spartina in Humboldt Bay within the salt marsh on Tuluwat Island, herein referred to as "MITIGATION PROJECT." The project is more particularly described in the final Wetland Mitigation Plan, dated July 2019, and is herein referred to as WMP. A copy of the final WMP is attached to Cooperative Agreement 01-0394 as Exhibit D.
- 9. PARTIES agree that to complete MITIGATION PROJECT, work will be separated into Phase 1 and Phase 2 tasks.
- 10. HBHRCD assisted CALTRANS by completing Phase 1 tasks under Cooperative Agreement Number 01-0394 to partially satisfy Condition 5 of CDP #1-18-1078, the NEPA revalidation for ABTN PROJECT and the NEPA revalidation for HBTS PROJECT.
- 11. HBHRCD desires to continue assisting CALTRANS by implementing Phase 2 tasks under this Amendment Number 1 to Cooperative Agreement 01-0394 ("AMENDMENT NO.1") and fully satisfy Special Condition 5 of **Exhibit A**, **Exhibit B**, and **Exhibit C**.

- 12. PARTIES agree that this AMENDMENT NO. 1 amends **Exhibit D** to add new reporting timelines and will hereby be known as **Exhibit D-1** and is attached hereto and made a part of this AMENDMENT NO 1.
- PARTIES agree that this AMENDMENT NO. 1 shall address the terms and conditions solely for Phase 2 tasks in order to fully satisfy Special Condition 5 of Exhibit A, Exhibit B, Exhibit C, and Sections 1.4, 2.1, and 3.2.2 of Exhibit D-1.
- 14. PARTIES agree that this AMENDMENT NO. 1 amends Exhibit E to add costs for HBHRCD to implement Phase 2 tasks. Under this AMENDMENT NO. 1 the total cost for HBHRCD to implement Phase 2 tasks is not to exceed \$6,734,137.06 as described in Exhibit E-1, attached hereto and made a part of this AMENDMENT NO. 1.
- 15. PARTIES acknowledge that this AMENDMENT NO. 1 is not intended to address the long-term management of Tuluwat Island after success criteria are achieved or to otherwise obligate HBHRCD to perform work other than the Phase 2 tasks defined in Exhibit D-1. This AMENDMENT NO. 1 also will not address or include the financial commitment needed for the endowment.
- 16. PARTIES will now define herein below the terms and conditions under which this AMENDMENT NO. 1 will be implemented.

#### **SECTION I**

#### **HBHRCD AGREES:**

- 1. That following the completion of Phase 1, HBHRCD provided CALTRANS with a cost estimate to complete Phase 2 tasks, costs that include, but were not limited to, the Request for Bids for the Tuluwat Island Spartina Removal Project, the bid amount of the awarded Spartina removal entity and HBHRCD administrative costs. The Request for Bids for the Tuluwat Island Spartina Removal Project, and all related addenda, are attached hereto as **Exhibit H**.
- 2. To perform all necessary administrative and contract management services to ensure the Phase 2 tasks are performed in a timely and complete manner.
- 3. To provide CALTRANS with copies of the executed contract between HBHRCD and the Spartina removal entity that was selected under Phase 1, to complete Phase 2 tasks.
- 4. That under this AMENDMENT NO. 1, HBHRCD, or its contractors, will implement Phase 2 tasks as defined in Sections 1.4, 2.1, and 3.2.2 of **Exhibit D-1**.

- 5. That at least two (2) weeks prior to commencement of the work identified in Section 2.1 of Exhibit D-1, HBHRCD, or its contractors, will create a Site-Specific Spartina Removal Plan ("REMOVAL PLAN") and submit it to CALTRANS, for CALTRANS review and approval. CALTRANS will submit REMOVAL PLAN to CCC for final approval. The REMOVAL PLAN must address all of the components identified in Section 1.4 of Exhibit D-1 including, but not limited to, summarize site evaluations, presurvey studies, surveys completed, and any other action taken, as required by Special Condition 5 of Exhibit A, Special Condition 4 of the CDP #1-14-0249, and the Final Programmatic Environmental Impact Report for the Humboldt Bay Regional Spartina Eradication Plan, Volume 1, dated March 21, 2013, ("FPEIR"). The FPEIR, CDP #1-14-0249, and Humboldt Bay Regional Spartina Eradication Plan were incorporated into Cooperative Agreement 01-0394 by reference.
- 6. To perform the work as described in Sections 2.1 and 3.1 of **Exhibit D-1**. This work will include the initial treatment work consisting of the primary Spartina removal in the first three (3) years and the four (4) year monitoring and maintenance of Spartina to pursue the MITIGATION PROJECT's success criteria.
- To follow monitoring protocols and reporting requirements as outlined in Section 3.2.2 of Exhibit D-1 that will occur following the initial treatment, for three (3) years during the maintenance and monitoring period, and after MITIGATION PROJECT completion when success criteria have been met.
- 8. To prepare the following reports and submit to CALTRANS for review and approval, whereafter Caltrans will submit the reports to the CCC:
  - a. Initial Removal/As Built Report. Within 30 days of the completion of the initial treatment (anticipated after Year 3, October 2024), a report will be submitted including information documenting the success of the initial treatment, areas needing additional treatment, Spartina coverage, and areas lacking in native marsh vegetation.
  - Annual Monitoring Reports. Following the initial treatment and four (4) years, HBHRCD, or its contractors, shall submit three (3) annual reports (anticipated Years 3-6, October 2024-2027) documenting Spartina removal activities, monitoring results, and field verification.
  - c. Final Monitoring Report. Following the four-year maintenance and monitoring period (anticipated after Year 7, October 2028), a report will be submitted evaluating whether the restoration site has met the goals and performance and success criteria as described within Section 5.B.12 and 5.B.13 of **Exhibit A**. The final monitoring report shall include a summary of the monitoring results and a description of how the final monitoring results meet the success criteria.

- 9. To adhere to the updated reporting timelines as outlined in Section 3.2.2 of **Exhibit D-1** to the extent that they are applicable to the Phase 2 tasks.
- 10. That all Phase 2 tasks performed by HBHRCD, or performed on HBHRCD's behalf, shall be performed in accordance with all state and federal laws, regulations, policies, procedures and standards and as set forth in Cooperative Agreement 01-0394, except as amended by this AMENDMENT NO.1. HBHRCD further agrees that all work performed by HBHRCD, or performed on HBHRCD's behalf, will also be performed in a manner consistent with Sections 1.4, 2.1, and 3.2.2 of Exhibit D-1 and in accordance with the FPEIR, associated Programmatic CDP #1-14-0249, and the Humboldt Bay Regional Spartina Eradication Plan, dated April 5, 2013.
- 11. That CALTRANS has obtained a right of entry onto the property, known as Tuluwat Island, where Phase 2 tasks as described in **Exhibit D-1** will be implemented. HBHRCD agrees that HBHRCD and its contractors, will comply with all the terms and conditions thereof. A copy of the right of entry is attached to Cooperative Agreement 01-0394 as **Exhibit F**. CALTRANS warrants and represents that the right of entry allows for entry onto the property by HBHRCD and its contractors to perform the work contemplated by this AMENDMENT NO. 1.
- 12. To comply with environmental approval and/or resource agency permits and/or approvals set forth in Section 1.3 of **Exhibit D-1** to the extent that they are applicable to Phase 2 tasks.
- 13. That HBHRCD and its contractors will take all necessary precautions when implementing the Phase 2 tasks defined in **Exhibit D-1** in order to avoid and minimize ground disturbing activities that may impact known archaeological and cultural resources through the use of exclusion areas and alternative methods of Spartina removal in sensitive areas (ESA-Environmentally Sensitive Area). HBHRCD further agrees to provide an archaeological monitor, on-call osteologist, and tribal monitor, which tribal monitor will be selected by the Wiyot Tribe, in accordance with **Exhibit F and Exhibit G** which are attached to Cooperative Agreement 01-0394.
- 14. To submit an initial invoice in the amount of \$1,327,841.00 to CALTRANS within thirty (30) days after the execution of this AMENDMENT NO.1.
- 15. HBHRCD is not required to deplete the entirety of this initial invoice prior to submitting to CALTRANS monthly billing statements in arrears.
- 16. HBHRCD may retain a portion of this initial invoice payment for cash flow purposes and anticipated large expenditures. Upon completion, if retained funds are more than MITIGATION PROJECT costs, HBHRCD shall refund CALTRANS for any cost overages as a result of retention of advanced funds.

- 17. Thereafter, to prepare and submit to CALTRANS monthly billing statements in arrears for HBHRCDs' actual expenditures incurred pursuant to Phase 2 work under this AMENDMENT NO.1.
- 18. The total amount of \$6,734,137.06 represents CALTRANS' total financial obligation for all Phase 2 tasks to be performed by HBHRCD or its contractors pursuant to this AMENDMENT NO.1.
- 19. To use one hundred percent (100%) of CALTRANS' funds in order to satisfy HBHRCD's obligation and responsibilities for Phase 2 tasks, as set forth in this Agreement.
- 20. To begin Phase 2 tasks within 30 days of receipt of the initial payment of \$1,327,841.00 which amount represents approximately 20% of the total costs to perform the work identified in Phases 1 and 2 of the MITIGATION PROJECT.

# **SECTION II**

### **CALTRANS AGREES:**

- 1. To pay HBHRCD within forty-five (45) calendar days of receipt of HBHRCD's signed initial invoice thereof the amount of \$1,327,841.00 for Phase 2 tasks under this AMENDMENT NO. 1.
- 2. Thereafter to pay HBHRCD within forty-five (45) calendar days of receipt of HBHRCD's monthly billing statements in arrears for HBHRCDs' actual expenditures incurred by HBHRCD pursuant to this AMENDMENT NO. 1. However, in no event shall CALTRANS total financial obligations exceed the amount of \$6,734,137.06
- 3. That HBHRCD is not obligated to perform any work until it receives the first initial payment of \$1,327,841.00 from CALTRANS.
- 4. That if additional property rights and/or rights of entry are required to implement Phase 2 tasks as defined in sections 1.4, 2.1, and 3.2.2 of **Exhibit D-1**, CALTRANS will acquire such rights. Any additional rights acquired shall also include rights for CALTRANS, HBHRCD personnel and its contractors. CALTRANS shall provide HBHRCD a copy of all additional rights acquired by CALTRANS.
- 5. That if additional environmental approvals and/or resource agency agreements, permits, and/or approvals are required to implement Phase 2 tasks in sections 1.4, 2.1, and 3.2.2 of **Exhibit D-1**, CALTRANS will, at its expense, work with HBHRCD in obtaining said

approvals, agreements, and permits. The PARTIES will provide each other a copy of all additional approvals, agreements, and permits acquired, and each shall comply with the terms thereof.

- 6. That if success criteria are not achieved, as determined by the CCC, following the four years of monitoring set forth above in paragraph I, 8, b, to pay, at its expense, for additional years of monitoring.
- 7. That at CALTRANS' cost, to review the REMOVAL PLAN. After approval, CALTRANS will submit the REMOVAL PLAN to HBHCRD and the CCC.
- 8. That at CALTRANS' cost to adhere to the reporting timelines as outlined in Section 3.2.2 of **Exhibit D-1**
- 9. That at CALTRANS' cost, to perform the work identified in Section 3.2.1 of Exhibit D-1.
- 10. To provide a copy of the ABTN PROJECT's material amendment and CDP #1-16-0122 to HBHRCD after the material amendment is issued and acknowledged by the City of Arcata.
- 11. To provide a copy of the HBTS PROJECT's CDP to HBHRCD after it has been issued and accepted by the County of Humboldt.

# **SECTION III**

# **IT IS MUTUALLY AGREED:**

- 1. That the reporting timelines have been updated as described in **Exhibit D-1**.
- 2. That the Budget has been updated to include additional costs associated with Phase 2 tasks as described in **Exhibit E-1**.
- 3. CALTRANS warrants and represents to HBHRCD that its has made a legal determination that the prevailing wage requirements set forth in Chapter 1 of Part 7 of Division 2 of the California Labor Code and the federal Davis-Bacon Act are not applicable to the PHASE 2 TASKS and that HBHRCD's contractor and their subcontractors are not obligated to pay prevailing wages for said work. Accordingly, CALTRANS instructed HBHRCD to issue, and HBHRCD issued in reliance upon CALTRANS' determination, an addendum to the Request for Bids issued by HBHRCD on May 21, 2021 for the PHASE 2 TASKS, to remove the previously stated requirement

that the contractor selected by HBHRCD to perform the PHASE 2 TASKS comply with the prevailing wage requirements of the California Labor Code or its federal counterparts.

- 4. In the event it is later determined or otherwise adjudicated that the prevailing wage provisions of the California Labor Code or its federal counterparts are applicable to the PHASE 2 TASKS, CALTRANS' total financial obligations set forth in Section I, Sub-paragraph 11, above, shall be adjusted upwards to include the additional labor costs incurred by HBHRCD's contractor(s) and their subcontractors to meet their obligations under the applicable prevailing wage laws, including, but not limited to, an amount for retroactive and prospective payment of prevailing wages, penalties or other assessments imposed by a government entity having jurisdiction over prevailing wage laws.
- 5. Further, CALTRANS shall indemnify, defend, and hold HBHRCD, its officers, directors, agents, contractors, and employees, harmless from and against any and all claims, damages, losses, expenses, fines, penalties, judgments, demands and defense costs (including, without limitation, actual, direct, out-of-pocket costs and expenses and amounts paid in compromise or settlement and reasonable outside legal fees arising from litigation of every nature or liability of any kind or nature including civil, criminal, administrative or investigative) arising out of or in connection (i) any action (whether administrative or at law) against HBHRCD, its officers, directors, agents, contractors, or employees alleging a violation of any provision contained within Chapter 1 of Part 7 of Division 2 of the California Labor Code (or any regulation promulgated thereunder) or the Davis Bacon Act (or any regulation promulgated thereunder) concerning the payment of prevailing wages for the Phase 2 tasks (ii) any determination by the Department of Industrial Relation or other State agency or federal agency having jurisdiction over the payment of wages that HBHRCD, its officers, directors, agents, contractors, or employees alleging a violation of any provision contained within Chapter 1 of Part 7 of Division 2 of the California Labor Code (or any regulation promulgated thereunder) or the Davis Bacon Act (or any regulation promulgated thereunder) concerning the payment of prevailing wages for the Phase 2 tasks. This sub-paragraph shall survive the termination of the AGREEMENT and this AMENDMENT NO. 1. CALTRANS' obligations under this sub-section shall not be subject to or otherwise limited by the total financial obligations set forth in Section I, Sub-paragraph 11, above.
- 6. That Cooperative Agreement 01-0394 shall terminate on December 31, 2029; however, all indemnification, document retention, audit, claims, environmental, legal challenge, hazardous material, operation, maintenance, and ownership articles will remain in effect until terminated or modified in writing by mutual agreement. This Agreement can be amended by written agreement by the parties.
- 7. All other terms and conditions of Cooperative Agreement 01-0394 shall remain in full force and effect.

8. This AMENDMENT NO. 1 is hereby deemed to be a part of Cooperative Agreement 01-0394.

### **SIGNATURES**

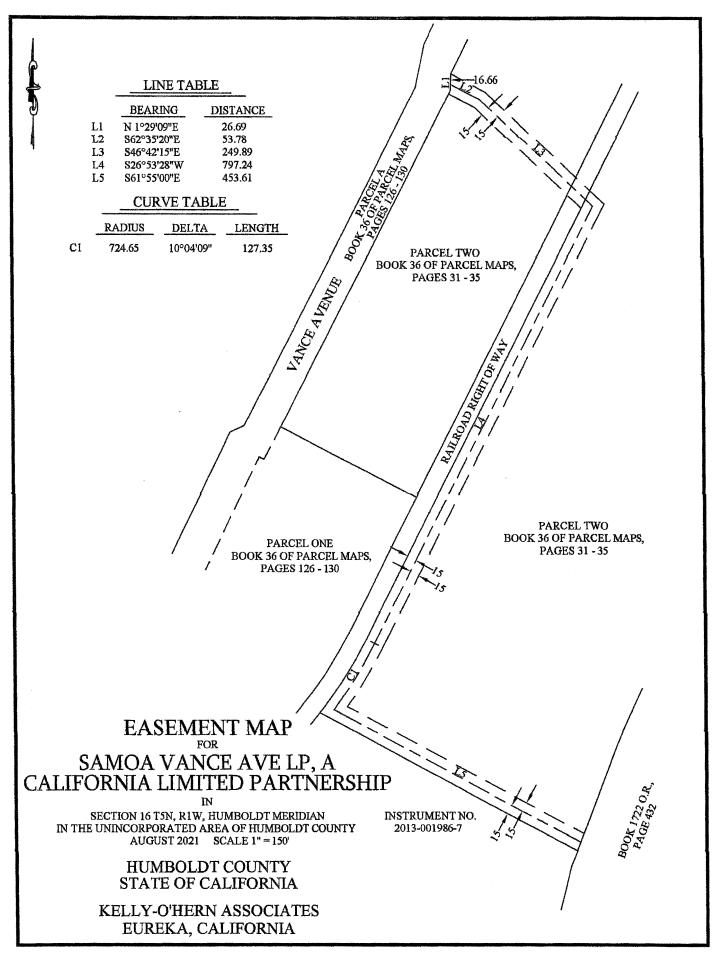

# TITLE: Letter of Support for Senate Bill (SB 307) A Bill Prohibiting Spending State Moneys for Any New Bulk Coal Terminal Project within the County of Humboldt

**STAFF RECOMMENDATION:** Staff Recommends that the Board submit a letter of support for SB 307 and direct staff to continue to work with Senator McGuire, Humboldt County, City of Eureka and other partners to rail bank the former North Coast Rail lines North of Willits.

**SUMMARY:** As reported in the January 5th Times Standard, SB 307, introduced by state Sen. Mike McGuire (D-Healdsburg), would block a proposal to restore the defunct North Coast railroad in an attempt to export coal overseas from Montana, Utah and Wyoming through the Port of Humboldt Bay by prohibiting the use of state funds for any new bulk coal terminal project within Humboldt County.

**DISCUSSION:** The Harbor District has not been in discussions with any party about establishing a bulk coal terminal in Humboldt Bay. The Harbor District's efforts are focused on developing a new heavy lift terminal to support the emerging offshore wind industry. The Harbor District is responsible for port development as well as conservation and recreation programs. The District is on the front lines and regularly experience the negative effects of climate change with the ever-increasing storm events and the slow and steady impacts from sea level rise.

The District strongly supports the federal, State and local efforts to cut our dependence on carbonbased sources of energy and believe that renewable energy resources such as offshore wind are the future economic drivers for the port of Humboldt Bay and not coal exports.

The Harbor District has regulatory authority over all tidelands of Humboldt Bay below the high-water level and also hold public trust responsibility for the majority of the tidal and submerged lands of Humboldt Bay including all of South Bay and the Samoa federal navigation channels. The majority of the docks/terminals in fields landing and on the Samoa Peninsula are leased to private parties which

operate these facilities. The City of Eureka has Public Trust responsibility for the tidal and submerged lands along the Eureka waterfront.

#### LEGISLATIVE COUNSEL'S DIGEST

Existing law creates the North Coast Railroad Authority with various powers and duties relating to rail service in the north coast area of the state, including the authority to acquire, own, operate, and lease real and personal property reasonably related to the operation and maintenance of railroads, the planned transfer of all of the authority's assets, and the authority's dissolution. Under existing law, the state is not liable for any contracts, debts, or other obligations of the authority.

This bill would prohibit the use of state moneys to initiate or operate rail service on the authority's rail rights-of-way north of the City of Willits or for a project that is designed to rehabilitate, modernize, maintain, or repair an existing operation or facility, including a rail terminal, a railyard, a rail facility, and rail infrastructure, on the authority's rail rights-of-way north of the City of Willits. The Harbor District is responsible for port development as well as conservation and recreation programs; our port revitalization efforts are focused on developing a new heavy lift terminal to support the emerging offshore wind industry. The Harbor District is on the front lines and regularly experiences the negative effects of climate change with the ever-increasing storm events and the slow and steady impacts from sea level rise.

The District strongly supports the Federal, State, and local efforts to cut our dependence on carbon-based sources of energy and believe that renewable energy resources such as offshore wind are the future economic drivers for the Port of Humboldt Bay, not coal exports. California has made significant progress toward a clean energy future through many programs that promote renewable energy, energy efficiency and the energy storage technologies that are needed to decarbonize its energy system. "The 100 Percent Clean Energy Act of 2018," (Senate Bill 100 De León) builds on this progress by escalating the state's renewable energy procurement requirement and makes the advancement to 100 percent clean electricity a state policy.

California will need to sustain its expansion of clean electricity generation capacity at a record-breaking rate for the next 25 years. Under most scenarios analyzed in the SB 100 report, the state will need to build, on average, 6 GW of new solar, wind and energy storage resources annually to ween away from carbon-based fuels.

The Bureau of Offshore Energy Management is in the process of leasing areas off the Humboldt and Morro Bay coastline in the fall of 2022. Clean renewable energy is our future and therefore the Harbor District supports SB 307.

TITLE: Status Report on the Nordic Aquafarms Environmental Impact Report and Regulatory Agency Permitting Timelines for the Proposed Recirculating Aquaculture Facility at Redwood Marine Terminal II

**STAFF RECOMMENDATION:** Staff Recommends that the Board: Receive an informational report from Staff and take no action on this item.

**SUMMARY:** THIS IS NOT A HEARING. The Harbor District has a lease agreement with Nordic Aquafarms to develop an indoor recirculating aquaculture facility at Redwood Marine Terminal II. After consultation with the County of Humboldt, Coastal Commission, State Water Board, and Harbor District Staff it was determined that a consolidated Environmental Impact Report (EIR) would be prepared for the entire project and that the County of Humboldt would be the lead agency under CEQA. The County has Noticed the Availability of the EIR and is accepting Public Comments until February 18, 2022. <u>The County of Humboldt is the lead agency and all</u> comments on the EIR should be directed to the County and NOT to the Harbor District.

**DISCUSSION:** The purpose of this item is to provide the Board with a status report on the process and timeline that the Harbor District will follow when we are evaluating the Harbor District Master Intake Permit. The Harbor District has no regulatory jurisdiction over the land based portion or ocean discharge portions of this project. The Harbor District has already executed the lease agreement, approved a tenant relocation plan, and established an ocean outfall usage fee schedule. No additional actions are required or contemplated by the District at this time.

No action by any California Regulatory Agency can be taken without first complying with the California Environmental Quality Act (CEQA). Because the County of Humboldt is the lead agency, the County must take action on the CEQA document before the Harbor District begins the public review portion of our Master Baywater Intake Permit. It is important that the public and applicant has a clear understanding of the process. Therefore, the Harbor District will NOT

be conducting any Hearings or soliciting for any public comments until after the County completes it review of the CEQA and Permit for the land based portions of the project.

The Harbor District is the applicant and will be developing the Master Baywater Intake system at the existing Redwood Marine Terminal II and Red Tank "sea chests" that were installed with the former pulp mill and lumber mills on the Samoa Peninsula. The Master Baywater Water Intake system will be permitted and designed for multiple aquaculture and other approved users that have received a Coastal Development Permit to operate. Although the Nordic Aquafarms will be the primary user of the bay water intakes, they will be one Harbor District's customer and other current and future tenants will benefit from the Master Baywater Intake System.

# NOTICE OF AVAILABILITY DRAFT ENVIRONMENTAL IMPACT REPORT

Name of Project: Nordic Aquafarms Land-Based Aquaculture Project

**Project Description:** The applicant (Nordic Aquafarms California, LLC. (NAFC)) is requesting a Coastal Development Permit and Special Permit for the construction of a land-based finfish recirculating aquaculture system (RAS) facility, which includes the development of five buildings totaling approximately 766,530 square feet and the installation of 4.8 megawatt (MW) solar panel array mounted on building rooftops, covering approximately 657,000 square feet. The height of the tallest proposed building is 60 feet. The facility would have an annual production capacity of approximately 25,000-27,000 metric tons of Head On Gutted (HOG) fish once complete. The aquaculture facility would produce fresh head on gutted fish and fillets for delivery to regional markets. The species to be produced at the facility is intended to be Atlantic Salmon.

The project will include ancillary support features such as paved parking, fire access roads, security fencing, and stormwater management features. The project would require approximately 2.5 million gallons per day (MGD) of freshwater sourced from the Mad River, supplied by the Humboldt Bay Municipal Water District via existing infrastructure. The project would require approximately 10 MGD of salt water provided via upgraded intake infrastructure located adjacent to the NAFC Project Site. Treated wastewater would be discharged utilizing the existing Redwood Marine Terminal II ocean outfall pipe, which extends one and a half miles offshore. A total volume of 12.5 MGD is anticipated to be released daily. Wastewater discharge is permitted by the North Coast Regional Water Quality Control Board.

The Humboldt Bay Harbor, Recreation and Conservation District (District) proposes to upgrade/improve and operate two formerly used bay-water intake systems (sea chests) in Humboldt Bay. The water intakes are located approximately one-half mile apart along the Samoa Channel at the Redwood Marine Terminal II (RMT II) Dock and Red Tank Dock. The intake systems were operated by a pulp mill from around 1966 until the mill was closed in 2008. Salt water from the intakes would be used by District tenants and other entities for aquaculture and other allowable uses. A new water line would be installed from the RMT II Dock and Red Tank Dock water intakes to manifolds at RMT I, RMT II and NAFC. The project also includes installation of a fire suppression water line and fire hydrant replacement. The fire suppression line would share a trench with the bay water intake line. The bay water line and fire suppression water line would involve trenching except where it crosses an existing stormwater feature and where the bay water line would run on the edges of Red Tank Dock and RMT II Dock. This water line would be attached to an existing walkway or to a replacement structure of the same size or smaller. The fire suppression water line would terminate near the RMT I manifold, RMT II manifold and at Red Tank Dock. The fire suppression water line would have a maximum outside diameter of 12 inches. The bay water line would range from 1836 inch maximum outside diameter. The maximum width of ground impacts would be 19 feet in sections where both pipes occur and 17 feet where only one pipe occurs.

The proposed aquaculture facility will include life cycle development, from egg to harvestable fish, contained indoors in separate buildings connected by swim pipes for fish transfer. The facility would include the following design elements:

- 1. A hatchery operation where eggs are hatched, and fish fry grow to juvenile size (Building 3)
- 2. A grow-out operation with large tanks where fish are grown to market size (Buildings 1 & 2)
- 3. A fish processing facility from which fish is processed and fresh product is shipped out 4 days a week, coproducts are chilled and stored for sale (Building 4)
- 4. Backup systems that will enable critical functions to operate for many days in the event of a power outage
- 5. Oxygen generation plant and liquid oxygen storage
- 6. Water intake treatment that ensures consistently clean water for the fish (Buildings 1 & 2)
- 7. An advanced wastewater treatment plant to treat the discharge water, including a Moving Bed Biofilm Reactor, a membrane bioreactor, and Ultraviolet (UV-C) dosing (Building 5)
- 8. Administrative building and associated operations/maintenance facilities (Building 4)

**Project phasing:** The aquaculture facility is anticipated to be built out in two primary phases, with preliminary site preparation (Phase 0):

- 1. Phase 0 Brownfield Redevelopment (2022): asbestos abatement; structure demolition; soil remediation; waste stream characterization, transportation, and disposal.
- Phase 1 Brownfield Redevelopment and Aquaculture Facility Stage 1 (2022 2023): Intake and outfall connections; ground densification to prepare construction of building foundations; construction of Phase 1 grow-out module (Building 1), Central Utility Plant (Building 3), Fish Processing Plant/Administrative (Building 4), Wastewater Treatment and Backup Power (Building 5); Oxygen generation storage; stormwater systems; onsite and offsite biological mitigation.
- 3. Phase 2 Aquaculture Facility Stage 2 (2026 or 2027): Ground densification; Phase 2 grow-out module (Building 2); soil remediation; expansion of utilities; existing leach field decommissioning.

The proposed fire suppression systems and sea chests improvements are anticipated to begin prior to construction of Phase 1 of the aquaculture facility. Timing is dependent on obtaining all agency approvals and permits.

**Project Location:** The land-based aquaculture facility is located in the Samoa area, east of Vance Avenue, approximately 2,000 feet north from the intersection of Vance Avenue and Bay Street, on the property known as 364 Vance Avenue (Assessor Parcel Number 401-112-021). Water intakes are located approximately one-half mile apart along the Samoa Channel in Humboldt Bay at the Redwood Marine Terminal II (RMT II) Dock and Red Tank Dock (Assessor Parcel Number 401-112-014 and 401-031-040).

**List of Potential Significant Environmental Effects Mitigated to a Less than Significant Level:** The Draft EIR identifies significant impacts in the following California Environmental Quality Act (CEQA)

environmental issue areas: aesthetics, air quality, biological resources, cultural resources, energy, geology and soils, greenhouse gases, hazards and hazardous materials, hydrology and water quality, noise, population and housing, and transportation, utilities, and wildfire. As described in the EIR, all of these impacts can be fully mitigated to a level less than significant.

# TITLE: Review of Subcommittees and Change Subcommittees and Committee Assignments As Needed
