**AMENDMENT NO. 1 TO ORDINANCE NO. 12**

AMENDMENT TO ORDINANCE PROHIBITING THE DISCHARGE OF  
FIREARMS, PROHIBITING HUNTING AND PROHIBITING VEHICLES,  
INCLUDING MOTOR VEHICLES AND OFF ROAD VEHICLES,  
ON LANDS, TIDELANDS, SUBMERGED LANDS AND FILLED LANDS OF  
THE HUMBOLDT BAY HARBOR, RECREATION AND CONSERVATION  
DISTRICT, LOCATED AT THE EASTERLY END OF PARK STREET, NORTH OF  
THE FOOT OF PARK STREET AND WEST OF FRESHWATER SLOUGH IN THE  
UNINCORPORATED AREA OF HUMBOLDT COUNTY, NEAR EUREKA,  
CALIFORNIA CONTAINING 16 ACRES, MORE OR LESS

**THE BOARD OF COMMISSIONERS OF THE HUMBOLDT BAY HARBOR,  
RECREATION AND CONSERVATION DISTRICT DOES HEREBY AMEND  
ORDINANCE NO. 12 AS FOLLOWS:**

1. The title of Ordinance No. 12 shall be eliminated and retitled as the "Park Street Marsh Rules and Regulations Ordinance; an Ordinance Establishing Rules, Regulations, And Enforcement Procedures for the Park Street Marsh" as described in Exhibit A; and
2. Add No.5 "No person shall throw or deposit any solid or hazardous waste, or cause the same to be thrown or deposited upon any portion of the Park Street Marsh as described in Exhibit A. Solid waste shall be defined as any of a variety of materials which are discarded or rejected as being worthless and include:
  - (a) GARBAGE. All classes of putrefactive or easily decomposable animal or vegetable matter and shall include any matter or substances used in the preparation, cooking, dealing in, or storage of meats, fowl, fish, fruits, and vegetables which are subject to immediate decay and the attraction of flies or rodents, excluding Group 1 wastes or hazardous wastes as defined by State law.
  - (b) RUBBISH. All waste and refuse matter, accumulating in and about any lot or building and shall include tree trimmings, grass cuttings, dead plants and weeds, wood, leaves, dead trees or the branches thereof, chip, shavings, woodenware, printed matter, paper, pasteboard, grass, rags, straw, boots, shoes, natural soil, earth, sand, clay, gravel, loam, stones, bricks, plaster, Portland Cement, crockery, glassware, ashes, cinders, shells, and metals; provided however, the enumeration of such articles shall not be held or construed to be exclusive of other articles falling within the general definition of rubbish. The definition of rubbish herein shall not include Group 1 wastes or hazardous wastes as defined by State law.

The term "Hazardous waste" shall mean any toxic or hazardous substance, material or waste or any pollutant or contaminant or infections or radioactive material, including but not limited to those substances, materials or wastes regulated now or in the future under any local, State, or Federal statutes or regulations.
