E. CONSIDERATIONOF SUBMITTING A LETTER OF CONCERN TO THE COUNTY OF HUMBOLDT REGARDING THE GENERAL PLAN UPDATE.

Commissioner Pellegrini stated that her constituents had asked that the Board of Commissioners review and comment on the County's General Plan Update (GPU). She said there is information that needs updating and the Board of Supervisors needs to be educated on the District's role. Commissioner Pellegrini noted many changes to be made to the GPU. She also suggested CEO should make a presentation to the Planning Commission and/or the Board of Supervisors about the District's role. The Board of Supervisors has moved forward with a Citizens Advisory Committee and Commissioner Pellegrini said CEO should have a seat on that committee.

John Miller from the County stated they welcome updates to the narrative. He also said the Citizens Advisory Committee suggested by the Board of Supervisors is specific to McKinleyville and the Greater Eureka Plans. The Board of Supervisors approved an outreach plan to meet with the districts.

Tina Christensen said Supervisor Smith said he would put together a special advisory committee.

President Wilson suggested each Commissioner forward their comments to CEO.

Mr. Miller said he would forward to CEO the Planning Commission's markup of the GPU.

Tina Christensen said she understands there are wide-open policies until the Board of Supervisors votes to adopt. This harbor is the County's biggest asset besides timber and it deserves its own section of the GPU. She said she feels he harbor is not being acknowledged by the County's Economic Development Department and the GPU might be a source for grant funding for harbor projects.

Lee Ulansey recommended the Board of Commissioners formally ask for a seat on the Citizens Advisory Committee. Presentations are helpful, but being a part of the formal process is more beneficial.

President Wilson said he spoke with Supervisor Lovelace who promised the Harbor District would be included in the process.

Commissioner Marks said Supervisor Smith wants to put together a "select" committee to include all service districts and county-wide representatives.

Commissioner Pellegrini requested CEO send a letter to the Board of Supervisors formally asking for a seat at the table and the opportunity to give a presentation to the Planning Commission and to draft language for changes to the GPU.

COMMISSIONER PELLEGRINI MOVED FOR THE CONSIDERATION OF THE BOARD OF COMMISISONERS TO AUTHORIZE CEO TO SEND A LETTER TO THE BOARD OF SUPERVISORS REQUESTING HARBOR DISTRICT REPRESENTATION AT THE CITIZEN/COMMUNITY/SELECT COMMITTEE AND FOR CEO TO REQUEST A PRESENTATION TIME TO THE PLANNING COMMISSION. COMMISSIONER CURLESS SECONDED. MOTION CARRIED WITHOUT DISSENT.

Tina Christensen said the majority of the property along the Fields Landing channel is Coastal Industrial Dependent and cannot be used without getting boats through there. Commissioner Pellegrini said currently the north side of the bay entrance is not being used to the full potential and there is only one private user of South Bay. There needs to be more than one user for Corps maintenance. Ms. Christensen said that should be reflected in the zoning.

CEO stated the Fields Landing Channel is a deepwater channel maintained by the Corps of Engineers and is still functional. If the zoning changes, the Corps may lose interest in maintaining the channel.

ADMINISTRATIVE AND EMERGENCY PERMITS

CEO reported there were two Administrative Permits approved since the last Board meeting.
