MINUTES REGULAR MEETING OF THE BOARD OF COMMISSIONERS HUMBOLDT BAY HARBOR, RECREATION AND CONSERVATION DISTRICT

July 14, 2011

President Wilson called the regular meeting of the Board of Commissioners to order at 7:00 p.m.

President Wilson asked former Commissioner Ron Fritzsche to lead those present in the Pledge of Allegiance.

PUBLIC COMMENT

Jim Bilderback, a member of the local longshoreman union, asked about the nature and scope of the TJS Leasing and Holding Company project at Redwood Marine Terminal. CEO responded the Board is at the beginning of the lease negotiations for log and lumber exports. The ERTN approved a six-month period for TJS to work out the details of their project and develop performance factors. The Board is not to the point of negotiating the actual lease with TJS. Commissioner Higgins said TJS made a public presentation to the Board during which they showed the company to be a key player with the Port of Astoria and proved to have the capital and capacity for their local project.

Ron Fritzsche said he recently traveled to Manzanillo, Mexico, the largest Mexican West Coast port. On the north end of the large bay is the port and the resorts are situated at the south end. There is virtually no unemployment and large numbers of the new houses and businesses. The Kansas City Southern Railroad feeds Mexico. Manzanillo also has a large mangrove swamp that is being bulldozed to make room for the increased port capacity. Dr. Fritzsche suggested the Harbor District's port associations develop a hemisphere-wide strategy to protect natural areas and utilize those ports that are already developed.

Damien Mooney asked what is the length of time TJS is asking for on their lease. CEO responded negotiations are not to that level yet.

Dr. Allen's publication on the listing of fish in Humboldt Bay is the baseline used today. Dr. Fritzsche also said Dr. Allen highlighted the contribution of women to fisheries. He said "We will all miss George, but will all still 'flush with pride".
