MINUTES REGULAR MEETING OF THE BOARD OF COMMISSIONERS HUMBOLDT BAY HARBOR, RECREATION AND CONSERVATION DISTRICT

May 25, 2011

President Wilson called the Executive Session to order at 6:00 p.m.

Bob Figas, owner of Figas Construction, told the Board of Commissioners he sent a letter to the Board in January to request use of the Redwood Dock and a warehouse. He said he decided not to use the warehouse, but was still interested in the dock on a ship-by-ship basis. Logs are being decked currently on Danco property adjacent to the Redwood Marine Terminal property. Recently the Board entered into an Exclusive Right to Negotiate (ERTN) with another customer. Mr. Figas said he currently has 5-6 ships in line to come to Humboldt Bay and asked the Board to appoint two Commissioners to review dock usage and the potential for multiple users.

District Counsel stated included in the ERTN is the Board's right to lease the dock as long as it does not interfere with the rights of the holder of the exclusive right.

The Board of Commissioners then adjourned to Executive Closed Session.

President Wilson adjourned the Executive Closed Session at 6:51 p.m.

President Wilson called the regular meeting of the Board of Commissioners to order at 7:00 p.m.

President Wilson asked Andy Colonna to lead those present in the Pledge of Allegiance.

District Counsel reported on the items discussed during Closed Session: Conference with Real Property Negotiator on potential lease terms of District Property to TJS Holding and Leasing Company, Inc. and potential lease terms of District property to Timber Heritage Association - no action was taken.

Commissioner Pellegrini asked to have Item (d) pulled from the Consent Calendar for further discussion.

Item (d): Commissioner Pellegrini asked if there was potential for reclaimed lumber in the demolition of Building 14 at the Redwood Marine Terminal. CEO replied that Building 14 was built in the 1920's and was originally 1100'. Louisiana-Pacific started to dismantle the building in the 1980's and it is currently 200'. The building has sustained major storm and earthquake damage over the years and has significant structural issues; therefore, CAL-EMA will award disaster funds for the demolition. CEO stated staff tried to find people to salvage the building; but it is made of fir, not redwood; and due to the building's construction, the demolition will diminish the value of the lumber. CEO said the engineers would inspect the building for hazardous materials.

UNFINISHED BUSINESS

A. PUBLIC HEARING ON PROPOSED FY 2011/12 BUDGET.

District Treasurer stated there have been no changes to the budget since it was first presented to the Board on April 14. He read the summary as follows: Revenue \$2,178,509; Operating Expenses \$1,918,781; Non-Operating Expenses \$259,623; Excess Revenues Under Expenses \$105.

CEO stated there have been recurring requests for the Fields Landing Boat Yard to stay open longer hours during summer in order for the boat owners to be able to work on their boats. CEO suggested as a pilot project for the month of June a fee of \$40 per day will be charged for people wanting to work on their boat for extended hours from 5 p.m. – 8 p.m. and this fee will be included in the FY 2011/12 Budget. It was agreed the hours would be extended from May 1 – September 30.

CEO said the next Board meeting will be on June 8 and the Board will consider the 1st Reading of the FY 2011/12 Budget. The 2nd Reading and Adoption of the FY 2011/12 Budget will be at the June 23rd Board meeting.

E. CONSIDERATION OF APPOINTING TWO BOARD MEMBERS TO WORK ON LEASE NEGOTIATIONS WITH TIMBER HERITAGE ASSOCIATION.

Dan Hauser, member of the Timber Heritage Association, said he and Mike Kellogg would be happy to work with a committee of the Board and asked if the negotiations would be for a lease only or transfer in fee title. District Counsel responded the discussions could be as broad as they would like.

President Wilson appointed Commissioner Higgins and himself to work with CEO, District Counsel, Dan Hauser and Mike Kellogg on negotiations for long-term disposition of the property at Redwood Marine Terminal for the Timber Heritage Association.

F. CONSIDERATION OF APPROVAL OF A MECHANISM TO COLLECT AND RESERVE SUFFICIENT FUNDS FOR FUTURE MARICULTURE PERMITTING EXPENSES AS RELATED TO THE DISTRICT'S AQUACULTURE EXPANSION PROJECT.

CEO reported the Headwaters Fund Board unanimously approved a \$200,000 grant for prepermitting for the aquaculture expansion project with one condition: the Harbor District not return requesting more money when it is time to renew the permits. The Harbor District Board of Commissioners will need to approve a mechanism to collect and reserve sufficient funds for these needs. CEO stated the staff recommendation as follows: Staff recommends the District establish a "Mariculture Management Fund Reservation" that will be defined as follows: Each year, the District shall reserve 25% of the tideland revenue from mariculture operations on tidelands leased as a part of the District's mariculture expansion project. These funds are reserved for future expenses related to permitting and environmental compliance for mariculture activities on District tidelands.

Commissioner Pellegrini said she does not like the precedence this might set and does not agree with this use of public funds.
