# MINUTES REGULAR MEETING OF THE BOARD OF COMMISSIONERS HUMBOLDT BAY HARBOR, RECREATION AND CONSERVATION DISTRICT

#### PRESENT:

President Wilson called the regular meeting of the Board of Commissioners to order at 3:00 p.m.

#### PUBLIC COMMENT

Jan Kraepelien asked the Board of Commissioners to rehire David Hull as CEO. Mr. Kraepelien said he toasted the Board for their good work under Mr. Hull and roasted them for his termination. He said Mr. Hull always worked within the Board's policies and procedures, a test of his integrity. He asked the Board if they had another agenda for the Harbor District and he is concerned the Board has lost their opportunity to highlight Humboldt Bay as a green port. Mr. Kraepelien also commented on the number of special meetings the Board has held lately and the fact the meetings are held during the day when it is hard for the public to attend. He said the Board has not violated the letter of the Brown Act, but has violated the spirit. They have hurt Mr. Hulls' reputation and they owe it to him to fix it.

#### INTERIM CEO REPORT

The Interim CEO reported as follows:

- The TIGER III grant pre-application was completed and submitted on September 29.
- Met with President Wilson and Jeff Cyphers and Bob Morris from TJS Leasing and Holding Co. Inc. regarding their project at Redwood Marine Terminal Berth 1.
- Participated in a conference call with President Wilson and Doug Steding, attorney for Taylor Mariculture Inc. regarding their Redwood Marine Terminal Berth 2 project.
- Met with President Wilson and Suzanne Dockal, Dockal and Associates, on the aspects of the TIGER III grant application, resulting in the contract before the Board this meeting.
- Met with District Treasurer and Dennis Ciocca regarding the annual Continuing Disclosure Report as part of the District's bond requirements.
- Annual Audit is ongoing.
- 9/30: A surplus sale on three boats was held. There were no bidders; another surplus sale will be held in the Spring.
- 9/30: A bid opening on vessel deconstruction of two boats was held. Figas Construction was the low bidder. A contract for the deconstruction will be presented at the next Board meeting.
- Met with Stas Margaronis and Leroy Zerlang on Mr. Margaronis' project.
- 10/6: Monthly staff meeting was held. The staff discussed emergency operations and was given a demonstration of the emergency generator, which would be used if the power goes out on Woodley Island for more than one hour.
- Director of Conservation continues to work on upland dredge disposal site, EPA Brownfields grant, Building 14 demolition, sea level rise and various permits.
- During the last two weeks, one ship completed loading and departed and another ship has docked.
- The Fire/Rescue Boat and Port Authority Security/Work Boat bid specifications have been sent to District Counsel for review prior to advertising.
- The District staff will take their CPR refresher course on October 20.

## Commissioner Pellegrini:

- Met with Director of Conservation and Supervisor Smith regarding the PG&E King Salmon canal. PG&E, who has stated they are committed to dredging the canal for the community, will be the lead on the environmental work for the dredging.
- Met with Commissioner Higgins, Dockmaster and Mike Cunningham regarding the Woodley Island Marina dog policy.

- Had a conference call with Doug Steding, attorney for Taylor Mariculture on their Berth 2 project.
- Met with Suzanne Dockal regarding the TIGER III grant application contract.
- Reported the Dockmaster had sent out the announcement for the CPR refresher course. He said it was important to notify the Board of staff training.
- Was pleased to report the TIGER III pre-application had been submitted.

# Commissioner Higgins:

- Attended the meeting at the Labor Temple organized by Sid Berg. Stas Margaronis was the main speaker on the topic of jobs creation.
- Met with Commissioner Pellegrini, Dockmaster and Mike Cunningham to discuss the Woodley Island Marina dog policy.
- Reported Director of Conservation has been working with Drew Barrett and Adam Wagschal on the creation of a co-management fisheries plan.

#### Commissioner Marks:

- Reported the Samoa Peninsula Fire Department would like to create a Community Services District, a long process that would include Manila and the rest of the peninsula.
- Stated the traffic has increased on the Samoa peninsula since the safety corridor was established on Highway 101. He said the speed limit needs to be lowered for all the congestion; there was a fatality just this last week.

A. CONSIDERATION OF CONTRACT WITH DOCKAL & ASSOCIATES FOR PREPARATION OF THE TIGER 2011 GRANT APPLICATION.

COMMISSIONER PELLEGRINI MOVED FOR THE APPROVAL OF CONTRACT WITH DOCKAL & ASSOCIATES FOR PREPARATION OF THE TIGER 2011 GRANT APPLICATION. COMMISSIONER MARKS SECONDED.

President Wilson said Suzanne Dockal was recommended by many as a local expert grant writer. The Board of Commissioners previously approved three projects as potential options for grant applications. He said the main focus should be on project #1, a mobile crane and yard loading equipment. The contract has a "not to exceed" total of \$6,500. President Wilson and Interim CEO are committed to assist Ms. Dockal.

Jan Kraepelien said the chances of being awarded the grant funding have diminished since the terminal of David Hull as CEO. He said America is about the means, not the end. The best thing the Board could do is to rehire David Hull as CEO.
