Louis Robinette commented that transportation is his background and that he recently sent a letter to the Board of Supervisors commenting on the future of Humboldt Bay. He also noted that he had recorded a program on the history of Humboldt Bay that he loaned to the District's CEO to copy for the District's files.

Melvin McKinney predicted that within a year, no one might be able to live in the City of Eureka due to the proposed water rate increases.

President Hunter congratulated Richard Marks for being elected to take his seat as 4th Division Commissioner and offered to help in any way.

Richard Marks thanked President Hunter for 20 years of service to the District and other community service organizations.

CEO REPORT

- 11/19: CEO chaired Humboldt Bay Harbor Safety Committee.
- CEO noted that over the past few weeks he, Director of Maritime Commerce Wilson Lacy and Director of Facility Maintenance Alan Bobillot have worked with various subcontractors responsible for moving the large engines for the PG&E powerplant project to ensure that they could be moved through the District's Fields Landing property. It was estimated that moving the engines from Schneider Dock to Fields Landing may commence within approximately 10 days.
- CEO noted that he, Wilson Lacy and District Counsel Paul Brisso continue to work with Taylor Mariculture on a possible exclusive right to negotiate agreement for a portion of the Redwood Marine Terminal property.
- CEO and Director of Conservation, Adam Wagschal, met with Humboldt Area Saltwater Angler, State Lands Commission representatives and CA Department of Fish and Game representatives regarding the status of the proposed Humboldt Offshore Reef project. Some progress continues to be made by the Ships to Reefs organization.
- CEO reported that comments have been received from various coastal local government and tribal agencies and the final MOA to establish a North Coast Local Agency Coastal Coordination Committee will be distributed for agency action.
- Adam Wagschal coordinated the first MPA external array proposal meeting and reportedly made good progress.
