President Curless called the Executive Closed Session to order at 6:06 p.m. Executive Closed Session adjourned at 6:29 p.m.

President Curless called the regular meeting of the Board of Commissioners to order at 7:00 p.m.

President Curless led those present in the Pledge of Allegiance.

District Counsel reported on the Executive Closed Session as follows: Status of negotiations with the District's employee bargaining unit per Section 54957.6. The employees approached the Board of Commissioners to begin negotiations on their next contract. Commissioners Curless and Marks have been appointed as the Human Resources Committee for negotiations. No other action was taken.

#### **PUBLIC COMMENT**

Paul Roller, representing PG&E, stated PG&E has been receiving negative press from the conflict between one of their contractors on the decommissioning of the power plant and the local labor unions. He said PG&E values its relationship with the Harbor District and the local labor community; and PG&E has partnered effectively with the local labor.

Roy Willis, fossil plant manager at PG&E's power plant, said the decisions on the decommissioning project were based on the least impact to the power plant's neighbors. PG&E supports the local community wherever and whenever they can.

Allison Talbot, government relations for PG&E, acknowledged the issues presented in the "My Word" article by Commissioners Higgins and Pellegrini in the Times-Standard. She said PG&E will not present half-baked, unsupported agreement to the fishermen on the wave energy project and PG&E's project manager has been in contact with the attorney representing the local fishermen. Ms. Talbot said she would be happy to give the Board updates as the project moves along.

#### **OTHER**

#### Presentation by City of Eureka on the Status of the Fishermen's Terminal Project

Eureka City Manager David Tyson, Assistant City Manager Mike Knight and Director of Redevelopment and Housing Cindy Trobitz-Thomas gave the Board of Commissioners an update on the progress of the Fishermen's Terminal and adjacent C Street Plaza. The work area consists of a dock, hoists and storage area. The adjacent property will eventually include a fish buying and distribution center where the public will be able to buy directly from fishermen. A pedestrian plaza will be built at the foot of the dock, with space for farmers' markets, live music, and other activities. The plaza will be the heart of a city redevelopment project, Seaport Village Square, with commercial space and residential units.

Commissioner Higgins commended the City for their accomplishments and said direct marketing from the fishermen to the consumer will benefit all.

#### **NEW BUSINESS**

A. CONSIDER AND DETERMINE WHETHER TO DIRECT DISTRICT STAFF TO PREPARE AND SUBMIT A TIDELAND LEASE APPLICATION TO STATE LANDS COMMISSION FOR THE HUMBOLDT OFFSHORE REEF PROJECT.

CEO reported since the mid-1980s the salmon season has been limited due to the Klamath Management Zone. In the mid-1980s, the charter salmon fishermen felt if there was a reef close by there would be an alternative for sports fishing.

These charter fishing boat operators contacted CA Department Fish & Game (DFG) in the late 1980s for assistance in developing an artificial reef and a potential reef location was located one mile northwest of the Humboldt Bay entrance was identified. The charter boat operators had no funding to build the reef to DFG's specifications for the reef – the idea fell apart.

However, in the last five years, the Harbor District has had some support to pursue an offshore reef. Ships to Reef presented to the District Board last year. They are currently pursuing a statewide effort designating five sink sites for cleaned ships, including Humboldt. The Humboldt Area Saltwater Anglers (HASA) also has interest and will grant \$1,500 towards the approximately \$3,000 fee for the District to submit a tideland lease application to State Lands.

COMMISSIONER HIGGINS MOVED TO DIRECT DISTRICT STAFF TO PREPARE AND SUBMIT A TIDELAND LEASE APPLICATION TO STATE LANDS COMMISSION FOR THE HUMBOLDT OFFSHORE REEF PROJECT. COMMISSIONER WILSON SECONDED.

Aaron Newman stated there is no opposition from the crab fishermen.

Commissioner Marks stated Commissioner Pellegrini wanted it on record she is in favor of the application.

Commissioner Wilson asked if HASA pays half the application fee, would that impact the independence of the project. CEO stated it would not. The tideland lease would be in the Harbor District's name; and most likely, non-Harbor District funds, in the way of grants, would be used for the project.

Casey Allen, HASA, suggested reef balls be used to construct the reef and HASA would solicit donations to manufacture and place them. He said HASA could be responsible for raising funds and getting the project done; Harbor District would be responsible for the bureaucratic obligations. Mr. Allen presented a \$1,500 check to the Harbor District Board to be used towards the application fee for the tideland lease.

MOTION CARRIED WITHOUT DISSENT.

B. COMMISSIONER HIGGINS MOVED TO DETERMINE WHETHER TO FILE A MOTION TO INTERVENE ON BEHALF OF THE DISTRICT IN FORTHCOMING FEDERAL ENERGY REGULATORY COMMISSION (FERC) PROCEEDINGS REGARDING THE PG&E WAVE ENERGY PROJECT LICENSING APPLICATION AFFECTING WATERS AT/NEAR THE PORT OF HUMBOLDT BAY AND SURROUNDING AREAS, AND INSTRUCTION TO DISTRICT COUNSEL TO PREPARE INTERVENTION MOTION. Commissioner Higgins said he appreciates PG&E's process, but FERC is in charge and regulates everything within three miles. He said PG&E frames the project as one square mile, but he is concerned

this will change because the time period has changed from five to ten years. Commissioner Higgins also said he would like to ensure the use of local labor on the project.

Commissioner Wilson asked if the motion to intervene is premature since the Board is asking staff to research the intervention.

Commissioner Marks stated Commissioner Pellegrini asked for the record to show she is in favor of the intervention. Commissioner Marks asked District Counsel for his opinion on filing the motion.

District Counsel stated at this point there is nothing to intervene in to; it's a strange FERC process. He said the Board can always withdraw at a later date. District Counsel recommended to the Board if they want to participate in the process, research would be brief, and they would have the motion ready to file when the window opens. The City of Fort Bragg has filed a similar motion; their template can be used.

Director of Conservation stated the word intervention sounds stronger than the actual action that would be taken. He said the Board would be put on a list that keeps the opportunity open to be able to comment in the future.

Commissioner Wilson said he does not want to appear to be in a reactionary mode.

Allison Talbot, PG&E, stated PG&E is going to file a draft pilot license agreement on Monday, March 1. She said PG&E welcomes and appreciates the District Board to be in an intervener status. Ms. Talbot stated Director of Conservation is correct in his explanation.

COMMISSIONER WILSON OFFERED A FRIENDLY AMENDMENT TO MOVE TO DIRECT STAFF TO DRAFT THE MOTION TO INTERVENE FOR FURTHER DISCUSSION AT A LATER MEETING UNLESS STAFF FINDS THE TIME COMES TO FILE PRIOR TO THE NEXT MEETING.

COMMISSIONER MARKS SAID HE WOULD ACCEPT THE FRIENDLY AMENDMENT.

Aaron Newman, President of Humboldt Fishermen's Association, asked the Board of Commissioners to register as interveners in order to become a part of the process. He said it is a complicated process; HFA is working hard to protect fishing interests. He asked the Board to authorize District Counsel to work with HFA's attorney to develop a contract with PG&E to deal with liability issues and compensation issues for injuries and losses within crab grounds.

Commissioner Higgins said this would be a gesture of collaboration with the fishermen.

Andy Colonna said FERC did not play straight on the relicensing of the Klamath Dams. He cautioned regarding a provision in FERC regulations where the time frame extends automatically.

Michelle Collins said she is concerned with waiting the extra two weeks until the next meeting. She urged the Board to direct staff to go forward.

COMMISSIONER HIGGINS SAID HE WOULD NOT ACCEPT THE FRIENDLY AMENDMENT.

Commissioner Marks asked if filing the motion is truly innocuous, what would be the harm of doing it now.

Michelle Collins said it is important to put the chair at the table now so it will be there when you need it. The risk of missing the deadline would be too harmful.

Tom Peters said the Board is not being asked to advocate or approve an action. If the Board is willing to be an intervener, then do it.

Alison Talbot said the draft license application is for a five-year project only. She said it is a dynamic project and PG&E is committee to transparency.

Leroy Zerlang said the fishing community deserves the highest respect and we should all work to protect the industry. He said the Board would be fools not to look at this potential niche when it comes with a bucketful of money. Don't beat up PG&E, no need to draw swords.

Commissioner Wilson said he is not trying to stop the intervention process, but the Board can be reactionary. If there is no need to jump, don't. The motion gives staff direction to file if the time comes prior to the next meeting.

Commissioner Higgins said it is not his intent to chew on PG&E; but he feels they are not truly transparent with this project. PG&E is a good corporate citizen, but the community needs to be cautious.

Andy Colonna said PG&E is not the problem; FERC is.

Commissioner Marks said it was his understanding there was no problem with the timelines; District Counsel felt PG&E had the timelines under control.

District Counsel said he has not yet thoroughly researched the timelines of the project, but Board approval of the motion gives him the authorization to pursue. In order to protect the Harbor District's interests and in keeping within the timelines, the filing may have to be done before the next meeting.

Commissioner Wilson said he was satisfied with the original motion.

Commissioner Wilson said he asked staff to put this resolution forward in order to make the procedures for check signing and funds transfers easier on staff. He said fiscal accountability is important, but the current procedures are inefficient. At the end of the month, the Board will receive a listing of checks written.
