President Curless called the regular meeting of the Board of Commissioners to order at 7:00 p.m.

CONSENT CALENDAR

COMMISSIONER PELLEGRINI MOVED FOR THE APPROVAL OF THE CONSENT CALENDAR. COMMISSIONER HIGGINS SECONDED. MOTION CARRIED WITHOUT DISSENT.

CEO REPORT

- Completion of the Woodley Island Marina work dock repairs is one week away. CEO reported the work dock will be like new and District Maintenance staff has done the majority of the work, potentially saving the District tens of thousands of dollars.
- Planning is ongoing for the Humboldt Bay Symposium.
- 3/4: The Budget Committee met and will meet one more time prior to the first budget presentation on March
- 3/4-5: CEO attended a CAPA meeting in Sacramento. Discussions center around port security, green programs and the state of the State; also discussed was air quality issues facing ports and preparation for the upcoming AAPA meeting in Washington DC.
- 3/16: CEO was interviewed on Jefferson Public Radio on the artificial reef program.
- Harbor Maintenance Tax update: The federal government only spends one-half of the tax collected on channel maintenance. HR4844, part of the WRDA bill, will provide 100% to be spent on harbor maintenance.
- Director of Conservation and CEO participated on a conference call with other agencies on regional sediment management. The District is the lead on this project.
- Director of Conservation has placed ads for graduate students to apply for work on the collaborative fisheries research project, which is grant funded.
- Charter boat agreements for a part of the collaborative fisheries research project will be considered for approval at the Board of Commissioner's next Board meeting.

STAFF REPORT

Director of Administrative Services reported the District received two refund checks from SDRMA for longevity in the Workers Compensation and Property/Liability Insurance Funds. The District has been a member in these two programs for over three years.

COMMISSIONERS REPORTS

Commissioner Pellegrini:

- Attended a breakfast on the LC1091.
- Reported discussion about crab pot limits is ongoing.
- Reported on the status of recreational salmon fishing season; commercial fishing will be better in Oregon than in California. Details on length of time and limits are still being discussed.
- Stated there will be a May 1 party for fishermen and their families and the Humboldt Women for Commercial Fishing "Humboldt Wild Seafood" logo, stickers, hats, banners, and meat tags will be unveiled. Commissioner Pellegrini said the Headwaters Fund assisted with the funding.

Commissioner Wilson:

- Attended the World Aquaculture Society Conference. He said most of the sessions he attended were on sustaining and integrating aquaculture on the West Coast. He said vendors are looking for anywhere on the West Coast to build onshore/offshore aquaculture and the number of jobs per dollars invested is high. Commissioner Wilson also took part in two tours.
- Reported he has discussed with CEO the possible creation of an informal 1st Congressional District Port and Marina Coalition, a partnership of the Harbor District and the Port of West Sacramento to form one entity to work with Congressman Thompson on grant applications, appropriations requests and port and harbor support.

Ted Kuiper thanked Commissioner Wilson for attending the World Aquaculture Society Conference. He urged the Board to incorporate in the annual budget funds for someone to attend this annual meeting. Aquaculture could be a major employment opportunity for Humboldt Bay.

Commissioner Higgins:

Related the history of his Father born on St. Patrick's Day and his Mother's passing on St. Patrick's Day and his annual celebration of his parents on this day.

Commissioner Marks:

- Met with CEO and Rick Martin of the North Coast Air Quality Management District to discuss air quality issues facing dock operators.
- 3/4: Took his required Ethics Training class, taught by District Counsel for California Special Districts Association.
- Attended the recent MLPA meeting and was overwhelmed by the amount of the information available.

ADVISORY COMMITTEE REPORTS

Commissioner Wilson:

- Stated his assigned session for the Humboldt Bay Symposium on shoreline protection and revetment on Humboldt Bay is progressing.
- Reported the Budget Committee met and the future is grim for the District if things stay steady. He said one contentious issue is how to plan for future dredging costs of Woodley Island Marina.

Commissioner Higgins:

Status of West Coast Marine Highway Corridor Designation

On March 3, Director of Maritime Commerce attended a West Coast Corridor Coalition meeting at the Port of Los Angeles office. The main goal of this group is to find a collaborative solution to fight the congestion challenge on the West Coast. MARAD also gave an update on the marine highway at this meeting, stating the application for the West Coast marine highway is currently in process.
