# **Background**

The Humboldt Bay Harbor, Recreation and Conservation District (District) intends to contract for construction services and all materials necessary to replace warehouse, shop, and office doors at the Samoa Pulp Mill site. The District's goal is to contract with a company (hereafter "Contractor") to provide and install commercial doors including opening preparation for overhead doors.

It is possible that the parameters of this project will be modified. It is expected that, after the close of this RFP period, the District and selected contractor will finalize project scope and schedule. There is no guarantee that any proposal will be accepted.

# Scope of Work

Provide and install twenty three commercial doors, including preparation for openings for nine doors.

# **Required Proposal Content**

Proposals should include the following information:

- Scope and schedule for project completion (including time from authorization to completion)
- Cost to deliver services conforming to specifications
- Equipment and techniques to be used
- Three professional references (include name, email and phone number).
- Qualifications, including proof of:
  - California Licensed Contractor
  - Commercial and Auto Liability Insurance

## **Proposal Selection Process and Criteria**

Proposals will be reviewed by District staff or designees. The following criteria will be used to

evaluate proposals:

- Proposed costs and timeline to complete the project
- Qualifications to successfully conduct the project

# **Application Procedure**

Submittals will be accepted until 4 p.m. September 29, 2014 by email to <u>icrider@humboldtbay.org</u> or <u>districtplanner@humboldtbay.org</u>. An electronic submittal is required. In addition, a hard copy proposal may also be delivered to the District Office (postmarks not accepted) at 601 Startare Drive Eureka, CA. This is not a requirement.
