

# ADDENDUM #3 (12/30/21): REQUEST FOR QUALIFICATIONS: REDWOOD MARINE MULTIPURPOSE TERMINAL REPLACEMENT PROJECT – DESIGN AND PERMITTING

**10. APPROXIMATE TIMELINE OF PROJECT INITIATION** An additional site visit on January 10, 2022 has been added to Section 10.

**11. OPTIONAL SITE VISITS** The Harbor District will host ~~two~~ three optional site visits on December 10, 2021, January 6, 2022, and January 10, 2022 which allow potential respondents an opportunity to review the project site in person and pose questions regarding the project. The District will not be preparing detailed notes or minutes of the Optional Site Visit. The District will also not be keeping track of questions, answers, and general discussions conducted during the Optional Site Visit. Questions which cannot be answered at the Optional Site Visit and that attendees specifically requested that the District provide a formal response will be All questions received during the optional site visits will be noted, with questions and responses distributed via addendum to this RFQ following each site visit. Interested parties are encouraged to attend the Option Site Visits. The specific times and meeting locations for each site visit will be posted on the Harbor District website and distributed via email to all parties who have registered as “Interested Parties” related to this RFQ. Site visits are optional and submittals from respondents who did not attend either site visit will be accepted.

## INFORMATION REGARDING OPTIONAL SITE TOUR:

- Within the RFQ, “Optional Site Visits” are described under Section 11 on page 22. Consistent with the schedule shown in the RFQ on page 21, the first Site Visit occurred on December 10, 2021. An Additional Site Visit on January 10, 2022 is added to Section 10 Approximately Timeline of Project Initiation.
- The January 6<sup>th</sup> and January 10<sup>th</sup> Site Visits will begin at 2:00pm and will go for as long as is required but is expected to conclude at 4:00pm. Interested parties should meet at 2:00pm at the far southern end of the parking lot of the Samoa Cookhouse, located at 908 Vance Ave, Samoa, CA 95564.
- The entire site tour will be conducted outside. All participants will be expected to wear face masks and follow standard COVID safety protocols.

**QUESTIONS AND RESPONSES:**

- No questions outside of what has been covered in Addendum #1 and #2 have been submitted as of 12/30/2021.
