AMENDMENT NO. 1 TO ORDINANCE 16

**AMENDMENT TO ORDINANCE ESTABLISHING RULES AND
REGULATIONS FOR THE BOAT BUILDING AND REPAIR FACILITY**

THE BOARD OF COMMISSIONERS OF THE HUMBOLDT BAY HARBOR, RECREATION AND CONSERVATION DISTRICT DOES HEREBY AMEND SECTION 6.10 OF ORDINANCE 16, BEING AN ORDINANCE ESTABLISHING RULES AND REGULATIONS FOR THE BOAT BUILDING AND REPAIR FACILITY, TO READ AS FOLLOWS:

The following words are hereby deleted:

SECTION 6.10. Storage of Trailers and/or Trailered Boats

Designated areas of land may be used for storage of boat trailers, trailered boats, or marine equipment as approved by the District upon payment of fees as designated by the Board of Commissioners. Storage of these items shall be prohibited except in areas designated by the District and after issuance of a Rental Agreement of Temporary Assignment by the District.

and the following words inserted:

SECTION 6.10. Storage of Vessels, Trailered Boats, Boat Trailers and Other Marine Related Equipment

Designated areas of land may be used for storage of vessels, trailered boats, boat trailers and other marine related equipment as approved by the District upon payment of fees as designated by Resolution by the Board of Commissioners. Storage of these items shall be prohibited except in areas designated by the District and after issuance of a Rental Agreement of Temporary Assignment by the District with the following conditions:


- (a) All rates established by the Board of Commissioners for usage of the Boat Building and Repair Facility shall be in accordance with the provisions of ARTICLE 5 of Ordinance 16.
- (b) Only vessels that arrive at the Boat Building and Repair Facility under their own power or are determined to be seaworthy by the Harbor Master will be eligible for "storage".
- (c) Under this Section, no work may be done to the vessel or equipment while in storage without written consent by the District and an agreement in writing to pay the Yard Rent as established by the Board of Commissioners. "Work" as defined for this Section includes but is not limited to, the maintenance, repair, replacement, rebuilding, removal and/or restoration or alteration of any portion of a vessel, boat trailer or other marine related equipment.
- (d) All licenses, registrations or documentation must be current on all vessels and equipment intended for use on public roads to be eligible for storage. Any vessel or equipment not currently licensed, registered or documented must be removed from the Boat Building and Repair Facility premises immediately upon expiration of said license, registration or documentation.
