#### Commissioner Pellegrini:

The Humboldt County Women for Commercial Fishing is working on promoting Humboldt Wild Seafood and a party for local boat owners and crew members will be held on May 1<sup>st</sup> to celebrate the promotion of the local products.

This year marks the 100<sup>th</sup> anniversary of the Pellegrini family fishing in Humboldt Bay.

- 3/31:A meeting will be held in San Francisco for local people to meet with Congressman Thompson regarding the possible closure of salmon season.
- Impact Assessment, the company collecting the socioeconomic impact information, will interview Paul Pellegrini in the new couple of weeks.

#### Commissioner Wilson:

- Stated he missed the last Humboldt Bay Symposium planning meeting.
- Reported he helped Friends of the Dunes on March 20 remove some of the 2,000 tires buried on their site to protect the bunker. The property is being readied for their bunker remodel.

#### Commissioner Higgins:

Stated he bought a fishing license and went fishing.

#### Commissioner Marks:

- Thanked Commissioner Wilson for his "tireless" efforts on behalf of Friends of the Dunes.
- Met with Commissioner Curless and the District employee union representatives.
- Reported Freshwater Tissue still plans to open the mill later this year. Currently unemployed mill workers are working with Congressman Thompson's office and the Employment Development Department to expedite funds for retraining.

#### Commissioner Higgins:

- Stated he will be attending the upcoming wave energy committee meeting to explain the Board of Commissioners' previous action of filing as an intervenor and to support the wave energy project with some concerns.

He also discussed case histories of lost business opportunities due to the absence of the railroad.
