- 4/22-24: The Humboldt Bay Symposium 2010 was held. There were 65 speakers, 10 sessions and 186 attendees. CEO reported the Symposium was highly successful.

OTHER

Presentation on a Pre-Feasibility Study Examining Oyster Mariculture Expansion in Humboldt Bay.

Commissioner Wilson stated there is the potential for increased mariculture in Humboldt Bay, which could bring in millions of dollars to the Humboldt County economy. Pre-feasibility work needed to be done in order to quantify the potential. Commissioner Wilson and Director of Conservation spoke with the students in Dr. Yvonne Everett's HSU class to see if they were interested in doing this field work.

The study was done by Carrie Carter-Griffin, Carson Hubauer, Andrew Minks and Elissa Robinson and who also gave their presentation to the Board of Commissioners.

Ted Kuiper commended the students for a very useful baseline document. He said he has worked on these issues over the past 30 years and was impressed the students had such a good grasp of the information in such a short time. Mr. Kuiper said currently less than 400 acres is being used for mariculture, which brings in \$6.2 million to Humboldt County's economy.

Commissioner Wilson requested District staff to investigate funding opportunities to do the feasibility study/business plan for mariculture expansion.
