RESOLUTION 2024 - 14

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE HUMBOLDT BAY HARBOR, RECREATION, AND CONSERVATION DISTRICT DECLARING THE RESULTS OF AN ELECTION HELD NOVEMBER 5, 2024

WHEREAS, a general election was held in Division 5 of the Humboldt Bay Harbor, Recreation, and Conversation District on Tuesday, November 5, 2024, for the purpose of electing the Division 5 Commissioner for a full term; and

WHEREAS, notice of said election was published, election officers appointed, supplies furnished and that in all respects the election was held and conducted, and the votes thereof received and canvassed and the returns thereof made and declared in the time, form and manner as required by the General Laws of the State of California governing election for special districts; and

WHEREAS, the County Elections Department canvassed the returns of the election and has certified the results to this Harbor Commission, the results were received by the Board Secretary, attached and made a part hereof as "*Exhibit A*"; and

WHEREAS, by way of this Resolution, the Board of Commissioners desires to declare the results of the election and such other and further matters as set forth below.

NOW, THEREFORE, the Board of Commissioners does resolve, declare, determine and order as follows:

SECTION 1. That the whole number of ballots cast in Division 5 was 10,787.

SECTION 2. That the names of the persons voted for at the election for Division 5 Commissioner are as follows:

- Wilfred "Wil" Franklin
- Jack Norton

SECTION 3. The Board of Commissioners does declare and determine as follows:

a. Jack Norton is elected as Commissioner, Division 5 of the Board of Commissioners for the full term of four years;

b. Wilfred "Wil" Franklin is not elected as Commissioner, Division 5 of the Board of Commissioners.

SECTION 4. The Board Secretary shall enter on the records of the District a statement of the result of the election (Exhibit A), showing: (1) the whole number of ballots cast; (2) the names of the persons voted for; (3) for what office each person was voted for; and (4) the total number of votes given for each person.

SECTION 5. That the Board Secretary shall make and deliver to each of the persons so elected a Certificate of Election signed by the Board Secretary and authenticated; that the Board Secretary shall also administer to each person elected the Oath of office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the District. The persons so elected shall then be inducted into the respective office to which he has been elected.

SECTION 6. That the Board Secretary shall certify the passage and adoption of this resolution and enter it into the book of original resolutions.
