President Wilson called the Executive Closed Session to order at 6:02 P.M.

President Wilson adjourned the Executive Closed Session at 6:40 P.M.

President Wilson called the Regular Meeting of the Board of Commissioners to order at 7:01 P.M.

Russ Gans, present in the absence of District Counsel reported on the Executive Closed Session as follows: Potential lease terms of property to Taylor Mariculture, Inc.; Potential lease terms of property to Timber Heritage Association – no action to report.

President Wilson asked Pete Johnston to lead those present in the Pledge of Allegiance.

PUBLIC COMMENT

Pete Johnston said that he is the current President of Timber Heritage Association and is in attendance tonight to introduce himself to the Commissioners. He stated he is looking forward to have a working with the District in the future.

Chief Executive Officer reported he is amazed by Timber Heritage Association's collection of rail cars.

Said that it is critical that he meet with stakeholders within the first 30 days of his arrival, and hopes the Commissioners will pass contact information on to him.

STAFF REPORT

Director of Conservation thanked all who worked on the Humboldt Bay Symposium Steering Committee. He also reported that he enjoyed touring Humboldt Bay with people involved in aquaculture, the Chief Executive Officer and Commissioner Dale.

Dockmaster said that she and Director of Facility Maintenance recently returned from Nanaimo, British Columbia, where they attended the 38th Annual Pacific Coast Congress of Harbormasters and Port Captains. She stated one of the topics on the agenda was how to tailor marinas to the needs of future audiences; this hot topic discussed new construction, reconstruction and renovation of marinas as agencies try to extend the life of their facilities. Dockmaster reported Woodley Island Marina was built to be a 40-year marina, and that it is 31 years old. She said the Maintenance Department has been innovative and has given the District facilities extra years. Dockmaster stated that renovation is a serious cost and that Woodley Island Marina will need a major renovation in the next 10 or 15 years. She reported that currently the trend is that boats are being built wider and the Marina will require more 30-foot slips.

Captain Petrusha reported the dredge *Essayons* arrived Tuesday and has been working on the bar and entrance to Humboldt Bay. He said he recently returned from Seattle with Captain Powell and Director of Facility Maintenance where they inspected the Port Security Boat; he said it exceeded their expectations and should be delivered on Thursday.

Stated the Humboldt Bay Symposium went extremely well and he enjoyed the speakers. Reported he heard many compliments from the community, including that it was the best Symposium they had attended.

Director of Conservation said the request for the District to join the efforts to remove the billboards came from Eric Nelson, Manager of the Humboldt Bay National Wildlife Refuge.

Commissioner Wilson reported the billboards are on tidelands, and that the property lines are not clear. He stated the billboard company had two years to produce evidence of money paid for renting the billboards, which they have not done. Commissioner Wilson said the Board of Commissioners previously wrote a letter of support for the removal of the billboards including excerpts added from the Management Plan. He stated that if nothing is done, further inaction would continue to allow private use of public lands with no public benefit. Commissioner Wilson reported that another course of action would be for the District to lease the land, although this action is not consistent with the Management Plan.

Commissioner Marks asked if the billboards are on District property, could the District recover the backlease money.

Chief Executive Officer said staff is clear on direction.

Karen Brooks asked if this issue was covered a few years ago when the problem was with USFWS not cashing the checks; she also asked if any agency had requested CBS Outdoor to attend meetings to work out this issue.
